AGREEMENT FOR OFFICIATING SERVICES IN 2022

1. Our School (all addresses in the basic e-mail message) agrees to the following terms and conditions with the Brazos Valley (BV) Chapter of TASO for providing high school volleyball officials.
2. All schools requesting officials from the BV Chapter must reply to the basic e-mail sent by the BV Chapter Assigner, Thomas Walkoviak with this attached agreement and schedules, if not emailed already, not later than July 15, 2022.
3. The BV Chapter will provide volleyball officials certified by TASO to officiate VB matches in accordance with TAPPS and NFHS rules. All confirmation of scheduled matches and assignments will be made through Arbiter. **It is the coach's responsibility to access the Arbiter every Friday and check to see that their matches for the following week are correctly scheduled.** If they are not, the coach should contact Thomas Walkoviak immediately by phone, text, or e-mail.
4. Any varsity match scheduled and not cancelled prior to game day (causing officials to be at your game site for a non-existing match) shall be reimbursed at the rate of one varsity match plus mileage for each assigned official. Same applies for sub-varsity and JH/MS matches. Coaches should review their schedule in Arbiter weekly to avoid scheduling errors. **IF OFFICIALS ARE ASSIGNED FOR MULTIPLE MATCHES AND THEY ARE NOT CANCELLED AT LEAST 8 HOURS BEFORE THE SCHEDULED START TIME, THEY WILL BE PAID IN FULL FOR ALL MATCHES ASSIGNED.**
5. Match fees and mileage reimbursement paid to officials will be in accordance with the current TAPPS Constitution and Contest Rules: Athletics Section 134. (<https://tapps.biz/volleyball>) Payments will be made by check in the mail to the officials address as listed on the pay slip that they turn in at the match site. TAPPS rules state that officials are to be paid promptly from the date of the match. The BV Chapter will use the metro mileage reimbursement plan listed in section 134. **Mileage for your school will be \$35 per official each match date.** Any questions on mileage claimed should be directed to Wally Simpson (President BV TASO Volleyball) or Thomas Walkoviak (Assigner BV TASO Volleyball).
6. All schools are allowed to scratch any number of officials from home site competition each season. Scratches must be made in an e-mail. If you desire to scratch any officials, please list their name in your e-mail along with reasoning. To be effective for the first schedules, scratches should be submitted no later than 7/15/2022. All scratches made during the season are done the same way and will be honored immediately.
