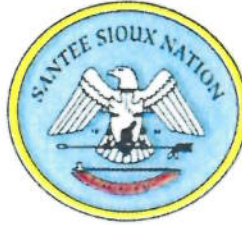

Dear Tribal Members:

The Santee Sioux Nation Tribal Council has approved a \$250.00 direct payment to all tribal members. While we wish this payment could be more, we hope this money will provide some relief during the cold months and holiday season. A date of distribution will be set soon as well as time periods on when you can pick up your payment. Please know, this payment will go out before Christmas.

Tribal members do not have to do anything except show up for the dates when the payment is distributed or update your mailing address if you want the check mailed to you. However, if the following information below pertains to you, then please follow the instructions.

This paragraph pertains to all individuals who are enrolling to become a member of the Santee Sioux Nation. You must have a completed enrollment application turned into the Santee Sioux Nation enrollment office by November 17th 2023 at close of business. Complete enrollment application is defined as; an application that meets tribal enrollment criteria. Includes the application, state certified birth certificate and social security number. Uncomplete applications after the deadline will not be eligible for payment.

This section of the letter is for parent/guardian who care for children who are in a guardianship, DTSU placement or some kind of legal/custody situation. In order to receive payment for such children, please submit legal documentation for any minors such as guardianship, DTSU placement, and custody papers. All documents need to be court ordered and/or notarized, and be advised, documentation turned in for last years payment may have expired. Please submit up to date documents. You must be the parent/custodial guardian with legal documentation to receive minor child's payment. This is to ensure the payment goes to the right person.

This paragraph is for tribal members who do not plan to be in Santee, NE on the check distribution days and want their payment mailed to them. Update your mailing address if your address has changed since last year's payment. The deadline for mailing address updates is November 17th at close of business. No one can change anyone else's address. The mailing address update must be in writing, and include name, DOB, current address and signature. You can fax this to 402-857-2385, or mail to Santee Sioux Nation Enrollment, Rt. 302 Box 5187

We are projecting a date of December 7-8 for distributing checks in Santee NE, but this date may change. We will set an exact time, date, and location for disbursement of payment soon, and post it on social media and on the tribe's website santeesiouxnation.com. After the distribution date all checks will be mailed to whatever address is on file at the enrollment department. This is a process, and we ask that you please be patient while we work to get mailing addresses updated and payment information ready.
