The purpose of the 101st Airborne Division Association is to preserve the memory of those who have served and to honor those who now serve in the 101st Airborne Division; to support and enhance the fame and glory of the Division; to maintain and strengthen the bonds of comradeship that have distinguished the members of the Division; and, to perpetuate the SCREAMING EAGLE spirit as to heritage and tradition for future generations.

Our Association is a nonprofit, apolitical organization established for the mutual benefit of the members without restriction or discrimination based on age, sex, religion, ethic group, national origin, status, handicap or disability. It is organized as a nonprofit 501(c)19 of the US Internal Revenue Code, incorporated under the laws of the State of Kentucky and operates in the State of Tennessee.

Unlike other veterans' organizations that have no ties to the active military, our association maintains a close relationship with the 101st Airborne Division. Our Association Office is on Fort Campbell. Our Association participates in division events, encourages active duty soldiers to participate in association events, encourages and supports active duty soldiers to join and to establish chapters, and provides financial assistance to needy active duty soldier families through the "Screaming Eagle Support Fund."

## Anyone Can Join the Association Who Supports our Purpose

## Regular Membership is open to:

- Anyone who, at any time, honorably served with the 101st Airborne Division.
- Anyone who honorably served and was a member of a unit (including Reserve or National Guard) that was attached or OPCON to the 101st Airborne Division.
- Anyone who honorably served as member of the United States Military.
- Any spouse, widow, immediate ancestral family member or lineal descendant of a regular member.

#### Associate Membership is open to:

• Anyone who does not qualify for regular membership.

## **Membership Information**

A "Regular Member" is one who may enjoy all Association functions and benefits to include voting in Association Elections and may qualify for an elected position. An "Associate Member" may also enjoy all member functions and benefits, but is excluded from voting in Association Elections and is disqualified from holding an elected position.

An "Annual Member" (regular or associate) is one who, in order to be and remain in good standing, must pay dues every year. NOTE: An Active Duty Soldier assigned to the 101<sup>st</sup> Airborne Division with an Annual Membership is exempt from annual dues if the soldier is a participant in the Association's Battalion/Squadron Chapter Program.

A *"Life Member*" (regular or associate) is one who has made a one-time life membership payment which satisfies all dues requirements for the life of the member. An "Annual Member" may convert to a "Life Member" at any time. However, the annual dues that were previously paid may <u>not</u> be applied to the cost of a "Life Membership."

## How to Join the Association

- Complete and submit an Application for Membership. NOTE: Your privacy is respected and safeguarded. Personal data is collected for statistical and demographic purposes; contact information is for administrative/emergency purposes. Providing your email address will allow you to receive Association email newsletters and email notices; your email address will not be shared.
- Provide proof of military service (IRS requirement). Copies (do not send originals) of any of the following are
  acceptable: DD Form 214; Orders for Assignment; Promotion; or Award; Veterans Affairs Card; Active Duty ID Card; or
  any other document that is proof of military service. Optional: Provide a photo in uniform.
  NOTE: To protect your privacy, ensure that you block out your Social Security Number on any documents where it may appear
  (military orders, DD-214, etc.) before submitting.
- Provide a check, money order or credit card authorization to cover dues. Those applying for Life Membership who desire to receive the print edition of the Screaming Eagle Magazine should also include the subscription fee.
