## COMMISSIONERS PROCEEDINGS February 5, 2018

The Jewell County Commissioners met February 5, 2018 at 8:30 a.m. Commissioners, Keith Roe, Steve Greene and Mark Fleming present. Carla J. Waugh, County Clerk, was present for the meeting.

The minutes of the January 29, 2018 County Commissioners meeting were approved.

Travis Garst, Solid Waste Director, reviewed the monthly activity report for January. Travis said he has training in March.

Commissioners reviewed the bid for bridge steel from Husker Steel - \$23,256.00. Steve Greene moved to accept the bid from Husker Steel - \$23,256.00 for bridge steel. Mark Fleming seconded the motion. Motion passed unanimously.
