## COMMISSIONERS PROCEEDINGS March 26, 2018

The Jewell County Commissioners met March 26, 2018 at 8:30 a.m. Commissioners, Keith Roe, Steve Greene and Mark Fleming were present. Carla J. Waugh, County Clerk, was present for the meeting.

The following were present for office head meeting: Chris Petet, Custodian; Joel Elkins, General Superintendent; Brenda Eakins, Treasurer; Don Jacobs, Sheriff; Anna Morgan, Register of Deeds; Travis Garst, Solid Waste Director; Nancy Marihugh, Health Nurse; and Gail Bartley, Noxious Weed Director, Emergency Preparedness Director and 911 Coordinator. Those absent: Shannon Meier, Ambulance Director; Anna Porter, County Appraiser; and Barrett Simon, Livestock Agent.

Brenda Eakins said that the Jewell County Treasurer's Office is unable to do driver's license until a new vision test machine is installed by the State.

Don Jacobs said he attended the KHP Communications meeting and the Crisis Management Training with the School District. Don advised that the Dane G. Hansen grant of \$50,000 for the radio console was approved.
