## COMMISSIONERS PROCEEDINGS April 27, 2020

The Jewell County Commissioners met April 27, 2020 at 8:30 a.m. Commissioners, Mark Fleming, Steve Greene, and Keith Roe were present. Carla J Waugh, County Clerk was present for the meeting.

Don Jacobs, Sheriff, joined the meeting. Wanda Backstrom, Agency Director for the 12<sup>th</sup> Judicial District Community Corrections and Dawn Snyder, 12<sup>th</sup> Judicial District Community Corrections joined the meeting via TEAM video conference. Wanda Backstrom reviewed the funding allocation comparison for FY20 received vs FY21 proposed. She reviewed the following grants for the adult corrections and for juvenile corrections:12<sup>th</sup> Judicial District Community Corrections Comprehensive Plan Grant Application for FY21; 12<sup>th</sup> Judicial District Community Corrections Program FY21 Behavioral Health Programming Grant Application; Juvenile Justice Comprehensive Plan Grant Application FY21; Juvenile Services FY21 Reinvestment and Regional Collaboration Grant Renewal. She requested the Commissioner's signature on some of the applications.

Mark Fleming moved that the proper officers sign the 12<sup>th</sup> Judicial District Community Corrections Comprehensive Plan Grant Application for FY21; 12<sup>th</sup> Judicial District Community Corrections Program FY21 Behavioral Health Programming Grant Application and the Juvenile Justice Comprehensive Plan Grant Application FY21. Steve Greene seconded the motion. Motion passed unanimously.

Don Jacobs, Sheriff, said he applied for and received unclaimed funds for the Jewell County Sherriff's Office. Don said he received a \$5,000 grant from Dane G. Hansen for defibrillators. He said they interviewed for a full-time deputy position.

Nancy Marihugh, Health Administrator and Kevin Peroutek, Noxious Weed Director, Emergency Preparedness Director and 911 Coordinator provided an update on the COVID-19 cases and reporting. Nancy Marihugh said the quarantine list is going down.

The minutes of the April 20, 2020 County Commissioners meeting were approved.

Joel Elkins, General Superintendent, reported on rock projects, tubes, and tree clearing. He said they are starting patch work on the Webber blacktop Road then will go to Y Road north of the lake. Joel also discussed equipment repairs.

Brenda Eakins, Treasurer, asked about plans for re-opening. Brenda Eakins said her concerns are with taxes due by May 11th that will bring more people into the building for possible exposure. The Commissioners said they are waiting for the Governor's announcement and Health Administrator's recommendation.

Darrell Miller, County Attorney, telephoned to discuss billing from EMS.

Chairman Fleming called for a special meeting on Friday, May 1, 2020 to discuss Jewell County's next phase of operations during the COVID-19 Pandemic.
