

COMMISSIONERS PROCEEDINGS

January 11, 2021

The Jewell County Commissioners met January 11, 2021 at 8:30 a.m. Commissioners Brent Beck, Steve Greene and Keith Roe were present. Carla J Waugh, County Clerk was present for the meeting.

Nancy Marihugh, Health Administrator, reported that in the last week Jewell County had 18 positive Covid-19 cases. She said they moved office equipment to the Clinic Building. They have some issues with the building that need to be addressed.

Judge Kevin Philips administered the oath of office to Carla J. Waugh, County Clerk; Keith Roe, County Commissioner, District 2; Brent Beck, County Commissioner, District 3; Amanda Davis, Register of Deeds; Alexandria Carabajal, County Attorney; and Donald J. Jacobs, Sheriff.

Joel Elkins, General Superintendent, discussed summer hours and asked if COVID Cares Act relief pay would be extended by Jewell County. The Commissioners thanked the Road and Bridge Department for moving the Health Department. Joel Elkins discussed clearing trees and ditches for fence building.

Steve Greene moved, and Brent Beck seconded to appoint Keith Roe as Chairman of the Board of County Commissioners for 2021. Motion passed unanimously.

Keith Roe moved, and Brent Beck seconded to appoint Steve Greene as Vice Chairman of the Board of County Commissioners for 2021. Motion passed unanimously.

Steve Greene moved, and Brent Beck seconded that the Jewell County Record be designated as the official County Newspaper. Motion passed unanimously.

Steve Greene moved, and Brent Beck seconded that all banks in Jewell County be designated as official depositories. Motion passed unanimously.

Keith Roe moved, and Steve Greene seconded to appoint Brent Beck as Jewell County's Representative for the Juvenile Justice Authority/Community Corrections Advisory Board. Motion passed unanimously.

Keith Roe moved, and Brent Beck seconded to reappoint Steve Greene as Jewell County's Representative for the North Central Kansas Regional Juvenile Detention Facility. Motion passed unanimously.

Steve Greene moved, and Brent Beck seconded to appoint Keith Roe as Jewell County's Representative for the North Central Regional Planning Commission Board. Motion passed unanimously.

Steve Greene moved to approve abatement numbers 2424 through 2428. Keith Roe seconded the motion. Motion passed unanimously.

The minutes of the January 4, 2021 County Commissioners meeting were approved.

Jenny Russell, Jewell County Community Development Association, reviewed the annual report.

Steve Greene moved, and Brent Beck seconded to approve Resolution 21-01 pertaining to Financial Statements and Financial Reports for 2021. Motion passed unanimously.

Kevin Peroutek, Noxious Weed Director, Emergency Preparedness Director and 911 Coordinator, provided a phase by population distribution chart for the COVID-19 vaccine. Kevin Peroutek said he submitted the final SPARK report and received a good review from the State.
