COMMISSIONERS PROCEEDINGS January 30, 2023

The Jewell County Commissioners met January 30, 2023, at 8:30 a.m. Commissioners Brent Beck, Keith Roe, and Ed Duskie, were present. Carla J. Waugh, County Clerk was present for the meeting.

The following were present for the office head meeting and provided an update for their department: Chris Petet, Custodian; Alexandria Pierce, County Attorney; Anna Porter, County Appraiser; Kevin Peroutek, Noxious Weed Director, Emergency Preparedness Director and 911 Coordinator; and Don Jacobs, Sheriff. Those absent: Cindy Becker, Health Administrator; Brenda Eakins, Treasurer; Nora Rhoades, Post Rock Extension District Director; Joel Elkins, General Superintendent; Amanda Davis, Register of Deeds; Travis Garst, Solid Waste Director.

Don Jacobs discussed personnel. He had a fuel contract with Randall Farmer's Cooperative Union for 2000 gallons at \$2.859 per gallon for a period of June 1, 2023, to October 31, 2023.

Anna Porter said the ag values for 2023 have decreased, but building values are increasing.
