The Jewell County Commissioners met, January 31, 2022, at 8:30a.m. Commissioners Steve Greene, Brent Beck and Keith Roe were present. Carla J. Waugh, County Clerk was present for the meeting.

The following were present for office head meeting Shannon Meier, Ambulance Director; Chris Petet, Custodian; Alexandria Carabajal, County Attorney; Anna Porter, County Appraiser; and Kevin Peroutek, Noxious Weed Director, Emergency Preparedness Director and 911 Coordinator. Those absent; Amanda Davis, Register of Deeds: Nora Rhoades, Post Rock Extension District Director; Cindy Becker, Health Administrator; Travis Garst, Solid Waste Director; Brenda Eakins, Treasurer; Don Jacobs, Sheriff; and Joel Elkins, General Superintendent.

Shannon Meier said that the EMS calls have slowed down but COVID-19 testing is still going strong. He has a meeting with KDHE today concerning testing.

Kevin Peroutek reported for the Weed Department that chemical sales have been robust this month. He said the chemical prices change frequently. Kevin said that Bill Burgess will be helping in the office. Kevin reported for the Emergency Preparedness Office that Jewell County participated in the Cyber Security Evaluation.
