

## COMMISSIONERS PROCEEDINGS

May 28, 2024

The Jewell County Commissioners met May 28, 2024, at 8:30 a.m. Commissioners Keith Roe, Ed Duskie, and Brent Beck were present. Carla J. Waugh, County Clerk, was present for the meeting.

The minutes of the May 20, 2024, Commissioners meeting were approved.

Ed Duskie moved, and Brent Beck seconded to approve abatement number 2598. Motion passed unanimously.

The following were present for the office head meeting and provided an update for their department: Chris Petet, Custodian; Don Jacobs, Sheriff; Cindy Becker, Health Administrator; and Carla J. Waugh, County Clerk. Those absent: Amanda Davis, Register of Deeds; Anna Porter, County Appraiser; James A. Vaughan IV, Solid Waste Director; Shannon Meier, Ambulance Director; Scott Wright, County Attorney; Joel Elkins, General Superintendent; Nora Rhoades, Post Rock Extension District Director and Brenda Eakins, Treasurer, and Kevin Peroutek, Noxious Weed Director, Emergency Preparedness Director and 911 Coordinator.

Chris Petet discussed issues with the boiler room door.

Cindy Becker said Nex-Tech switched over all computers in her department last week. She attended an Immunization Conference. She is working on budgets to be submitted.

Don Jacobs, Sheriff, said that several from the department attended the KCIKIS Conference. He said that Jeremy Luedke and K-9 Rambo attended certification training. Don said a taser re-certification class for the department is scheduled this week. He discussed the Fire Marshal's inspection for the jail.

Carla Waugh said her office has sent out budget request information to the 25 townships, 6 fire districts and 12 cemetery districts along with all of the county departments. Carla said they have applied for a domain name on behalf of Jewell County to set up new email accounts.

Brent Beck said he has received road concerns. Ed Duskie said he attended the Jewell County Council on Aging meeting. He has received several calls concerning the LEPC committee and calls about maintaining dirt roads. Keith Roe said he attended the JCCDA meeting.

Don Jacobs requested an executive session to discuss non-elected personnel. Keith Roe moved, and Ed Duskie seconded the motion to go into executive session for 5 minutes beginning at 8:52 a.m. to discuss non-elected personnel with Don Jacobs and Carla Waugh present. Motion passed unanimously. Regular session resumed at 8:57 a.m. with no action taken.

Ed Duskie moved, and Brent Beck seconded to go into executive session to discuss non-elected personnel for 10 minutes beginning at 9:05 a.m. with Joel Elkins present. Motion passed unanimously. Regular session resumed at 9:15 a.m. with no action taken.

Brent Beck moved, and Keith Roe seconded the motion to sign the Jewell County Solid Waste Director Employment Agreement. Motion passed unanimously.

Ed Duskie moved, and Brent Beck seconded to go into executive session to discuss non-elected personnel for 5 minutes beginning at 9:46 a.m. Motion passed unanimously. Regular session resumed at 9:51 a.m. with no action taken.
