

COMMISSIONERS PROCEEDINGS

June 15, 2020

The Jewell County Commissioners met June 15, 2020 at 8:30 a.m. Commissioners, Mark Fleming, Steve Greene, and Keith Roe were present. Houston Becker, Deputy County Clerk was present for the meeting.

The minutes of the June 8, 2020 County Commissioners meeting were approved.

Steve Greene moved that the proper officer sign the agreement for the Western Kansas Child Advocacy Center. Keith Roe seconded the motion. Motion passed unanimously.

The Commissioners discussed representatives for the 2020 Small Cities Community Development Block Grant.

Keith Roe moved to go into Executive Session beginning at 8:59 a.m. for 10 minutes with only the Commissioners present. Regular session resumed at 9:09 a.m. with no action taken.

Nancy Marihugh, Health Administrator, joined the meeting at 9:17 a.m. to discuss Health Department operations.

Darrell Miller, Attorney, joined the meeting at 9:55 a.m. with Don Jacobs, Sheriff, present. Darrell Miller discussed the commissary fund for the Sheriff's department. He requested the Commissioners telephone Randy Hofmeier, CPA for Lindburg Vogel Pierce Faris, for further advice. Don Jacobs explained what he would like to use the commissary funds for. Randy Hofmeier advised that the Commissioners write a resolution stating what these funds would be used for if they decided to move forward with the commissary fund. Darrell Miller said he would write up a resolution for Randy Hofmeier to review.
