Board of County Canvassers August 10, 2020

The Jewell County Commissioners Mark Fleming, Steve Greene and Keith Roe met on August 10, 2020 at 8:30 a.m. as the Board of County Canvassers, to canvass the ballots from the August 4, 2020 Primary Election. Carla J. Waugh, Jewell County Clerk/Election Officer was also present. Others present for the canvass were Josh Ney, Kathy Ungerer and Beth Salmon.

Carla J Waugh, County Election Officer reviewed the election night tabulation and the advance ballot count that was received after election night. Carla Waugh then reviewed the 28 provisional ballots and the reason for being provisional. She then went over the guidelines in the Kansas Election Standards Chapter 3 that provides guidelines for each situation and whether the ballot should be counted. The Commissioners agreed that 24 provisional ballots should be counted and 4 deemed invalid for counting. The special counting board opened and counted the provisional ballots with Josh Ney, Kathy Ungerer and Beth Salmon as observers. The special counting board tallied the votes and Carla Waugh presented them to the Board of Canvassers for review.

The ballots for the Primary Election were canvassed with 28 provisional ballots reviewed and 24 deemed valid and counted.

The canvassing was completed, and the board adjourned at 9:53 a.m.

The Jewell County Commissioners met August 10, 2020 at 9:54 a.m. Commissioners Mark Fleming, Steve Greene, and Keith Roe were present. Carla J Waugh, County Clerk was present for the meeting.

Joel Elkins, General Superintendent, had bids for a Semi Tractor to pull the belly dump trailer. Chairman Fleming read the following bids: Truck Center, Salina – 2021 Freightliner M2112 \$95,288; MCH Kenworth, Salina – 2021 Kenworth T880 \$105,480; Summit Truck, Salina – 2021 International HV613 \$98,650; and Summit Truck, Salina – 2021 Volvo VHD \$112,500. Mark Fleming moved, and Steve Greene seconded the motion to approve the bid of \$95,288 from Truck Center of Salina for the 2021 Freightliner M2112. Motion passed unanimously.
