The Jewell County Commissioners met November 30, 2020 at 8:30 a.m. Commissioners Mark Fleming, Steve Greene and Keith Roe were present. Carla J Waugh, County Clerk was present for the meeting.

The following were present for office head meeting: Kevin Peroutek, Noxious Weed Director, Emergency Preparedness Director and 911 Coordinator; Amanda Davis, Register of Deeds; Don Jacobs, Sheriff; Shannon Meier, Ambulance Director; Chris Petet, Custodian; Nancy Marihugh, Health Administrator; Nora Rhoades, District Extension Director; and Carla J Waugh, County Clerk. Those absent: Travis Garst, Solid Waste Director; Anna Porter, County Appraiser; Brenda Eakins, Treasurer and Joel Elkins, General Superintendent.

Kevin Peroutek reported that the Jewell County Noxious Weed Department sponsored the Regional Meeting. Kevin Peroutek said he was able to spray a few times this month. He said that the Emergency Preparedness Department has been coordinating the delivery of items ordered through the SPARK fund.
