

COMMISSIONERS PROCEEDINGS

December 13, 2021

The Jewell County Commissioners met December 13, 2021, at 8:30a.m. Commissioners Brent Beck, Steve Greene and Keith Roe were present. Carla J. Waugh, County Clerk was present for the meeting.

Brent Beck moved, and Steve Greene seconded to approve abatement number 2471. Motion passed unanimously.

The minutes of the December 6, 2021, County Commissioners meeting were approved.

Steve Greene moved, and Brent Beck seconded to sign the 2022 Employment Rules and Regulations for all Jewell County Departments. Motion passed unanimously.

Kevin Peroutek, Noxious Weed Director, Emergency Preparedness Director and 911 Coordinator, discussed the LEPC meeting and updating the Emergency Operations Plan.

Cindy Becker, Health Administrator, provided a report on the vaccine clinic they provided. She reported that the Rock Hills School Board is reviewing modified quarantine protocols at their special meeting today.

Joel Elkins, General Superintendent, discussed maintenance. Joel had a waterline agreement for approval. Steve Greene moved, and Brent Beck seconded to approve the waterline agreement with Republic County Rural Water District #1 to construct and operate a water line across public road right of way 260 Road at a point beginning 300 feet north of S Road and 260 Road intersection. Motion passed unanimously.

Keith Roe moved, and Brent Beck seconded to go into executive session for 5 minutes beginning at 9:21 a.m. to discuss non-elected personnel for the purpose to review an evaluation with Kevin Peroutek present. Motion passed unanimously. Regular session resumed at 9:26 a.m. with Kevin Peroutek signing his evaluation.

Shannon Meier, Ambulance Director, discussed pay scale.

Steve Greene moved, and Brent Beck seconded to approve the 2022 Commissioner's Calendar. Motion passed.
