



TERMS AND CONDITIONS

1-The Vehicle Renter (primary driver) is responsible for all damage caused to said vehicle, regardless of whether another party is at fault or the cause is unknown. The Renter is fully liable for the cost of any repairs, up to the value of the vehicle. Car insurance may cover all or part of the financial liability and third-party liability (for persons or property) regarding the rented vehicle, depending on the option selected by the Renter as detailed below:

- * LDW (INCLUDED IN THE RENTAL PRICE),
- * State Minimum Liability (USD \$10,000/\$30,000),
- * USD \$1,000.00 maximum out-of-pocket expense for vehicle damage or theft (*),
- * USD \$1,500.00 maximum out-of-pocket expense for vehicle damage or theft (**),
- * USD \$2,500.00 maximum out-of-pocket expense for vehicle damage or theft (***)

Provided there is no breach of this contract, the Renter and any authorized driver are covered for State of Florida minimum liability and financial liability (vehicle) in the amounts described in the preceding paragraph for vehicles with codes (A, B, C) (*), (D, E, F) (**), and (G, H, J) (***). The Renter named above may not allow persons NOT LISTED IN THIS CONTRACT to drive the vehicle. The Renter (Primary Driver) is subject to the terms and conditions of this Car Rental Agreement and is liable for any damage caused to third parties (persons or property), whether by the Renter themselves or by authorized drivers.

IMPORTANT:

*Florida state law mandates that the number of occupants in a vehicle must not exceed the number of seatbelts with which the vehicle is equipped.

** THE RENTAL VEHICLE MAY NOT LEAVE THE STATE OF FLORIDA. Should it do so, the renter (primary driver) shall bear full financial liability (for vehicle damage) and civil liability (regarding third parties or property); the amounts described in point (1) of this contract shall not apply, and an additional fee of USD 0.30 per mile shall be charged for every mile driven in excess of 1,000 miles.



2- RETURN OF THE VEHICLE:

The vehicle must be returned to the same location it was picked up for rental and on or before the due date and time listed above. Additional fees will be charged if the vehicle is not returned as specified above. Where permitted by law, the car renter authorizes us to process or release your credit card information on your behalf for all additional charges (Ex: Tolls, Traffic Violations, Towing, any court costs for fines and/or administrative expenses that may occur due to bad parking and other infractions that the Renter may incur during the term of the Car Rental as indicated above and to apply the payments made to the charges in the order that the Car Rental Company Automobiles deemed necessary.

3- TOLLS / TRAFFIC INFRACTIONS AND MORE:

"Regulation of traffic violations and bad parking: It is the responsibility of the person who rents the vehicle to pay the traffic fines and bad parking that occur during the rental period. It is very likely that these charges will be detailed once the rental period has ended. (As indicated in the contract that is signed at the beginning of the rental period.

SUNPASS / TOLLS: All units have a toll collection device / sensor. It is the customer's responsibility to pay any charges made during the rental period. This will be done 10 (ten) business days after the end of the trip, you will be informed of the total cost of these charges. This charge can be paid in CASH with a Bank Deposit, or it can be debited from the amount that has been given as a guaranteed deposit on the credit/debit card at the time of vehicle pick-up.

4- AT THE TIME OF THE RETURN: AT THE TIME OF THE RETURN:

The return will be made at the place agreed with MAAK AUTORENT at the time of the start of the trip, the schedule must be respected according to what the contract indicates.

If the schedule indicated above is not met, you will be charged (1) one more day of surcharge.

The vehicle will be delivered by MAAK AUTORENT. Totally clean and with gasoline. It is the customer's responsibility to return it in the same clean conditions and with a gas tank as it was delivered. If this does not occur, the following charges will apply: * GASOLINE: USD \$15 p / tank qtr (cars and medium SUV) USD 20 p / tank qtr (large SUV and VAN) *

THE FINAL INSPECTION, THE CUSTOMER WILL BE NOTIFIED IF THE VEHICLE HAS AN EXCESSIVE DIRT, (EXA.: Upholstery stains, CIGARETTE SMELL). If applicable, the amount to be charged will be USD \$150

"PLEASE DO NOT SMOKE INSIDE THE VEHICLE"

* **KEYS:** IN CASE OF LOST KEYS (Cost will be \$350) plus shipping costs



5- PAYMENT: PAYMENTS MUST BE RECEIVED IN "USA DOLLAR" CURRENCY. PAYMENT CAN BE CASH, CREDIT / DEBIT CARD.

6- DRIVERS: ONLY PERSONS INCLUDED IN THIS CAR RENTAL AGREEMENT OVER 25 (TWENTY-FIVE) YEARS OF AGE MAY DRIVE THIS VEHICLE.
