## VICTORY LANES CAPTAINS: READ TOURNAMENT RULES CAREFULLY

Team, Doubles and Singles events conducted on handicap basis. Handicap is 90% from 1100 in Team Event; 440 in Doubles; 220 in Singles. No limit to Handicap. Awards will be awarded to Actual and Handicap Champions of each event. PRIZE RATIO: TEAM, DOUBLES, SINGLES – minimum of 1 for 5 entries; ALL EVENTS – minimum 1 for 15 entries.

**AVERAGES:** ALL BOWLERS must enter at their highest certified league average for 21 games or more for 2024-2025 or highest average for 2023-2024 if no 2024-25 average. **SUMMER AVERAGES WILL NOT BE USED.** If a bowler has no past average as stated above, a current average as of **February 1, 2026**, for 21 or more games for the **2025-2026** season will be used. If a bowler does not have an average, they must enter at 220.

YOU CAN ONLY BOWL ONE EVENT PER SHIFT. YOU CANNOT BOWL THE TEAM EVENT, AND THE DOUBLES AND SINGLES EVENT DURING THE SAME SHIFT.

LANES WILL BE CONDITIONED PRIOR TO EACH SHIFT OF THE TOURNAMENT.

LIST ANY TOURNAMENT WINNINGS OR ANY RE-RATE INFORMATION ON A SEPARATE SHEET AND ATTACH TO THIS FORM, ATTACHMENT MUST LIST BOWLER'S NAME, TOURNAMENT AND AMOUNT OF PRIZE EARNINGS. (SEE RULE 319d)

**ALL BOWLERS AND TEAM CAPTAINS MUST BE AWARE OF USBC RULES**: (See USBC Rule Book for referenced rules) United States Bowling Congress rules and regulations will govern this tournament.

BOWLERS WHO ARE CERTIFIED IN ANOTHER LOCAL ASSOCIATION MAY ENTER BY PAYING A LOCAL MEMBERSHIP FEE OF \$10.00.

Rule 304 – AUTHORITY OF TEAM CAPTAIN, REFER TO RULE BOOK.

Rule 315d – A BOWLER MAY PARTICIPATE IN THE TEAM EVENT NO MORE THAN FOUR TIMES; DOUBLES AND SINGLES NO MORE THAN FOUR TIMES. NO MORE THAN TWO PBA PROS CAN BOWL TOGETHER IN THE TEAM EVENT. ONLY ONE PBA PRO CAN BOWL WITH THEIR PARTNER IN DOUBLES. First event bowled (team, doubles, or singles) score counts for ALL EVENTS Standings.

**RULE 315b** – Five-player team event – No more than three players on one team can place more than once in the prize list for position standings.

**RULE 319a** – AVERAGE- CONDITIONS THAT APPLY: As printed above, in addition USBC Youth or Collegiate Division sanctioned league averages shall be accepted. The 10 pins over average rule **does not apply** in this tournament.

**RULE 319e** – AVERAGE ADJUSTMENT FOR ENTRY. Rule will be posted in tournament office and each bowler will be questioned in accordance with the rule.

**RULE 322a** – TARDY PLAYERS: A bowler who misses one frame or more by not being present and ready to bowl in turn shall not be credited with any pins for the frames missed.

RULE 328 - CHANGING DELIVERY IN HANDICAP AND CLASSIFIED TOURNAMENTS.

YOU MUST REGISTER <u>45 MINUTES</u> IN ADVANCE TO WALK IN FOR THE TEAM EVENT OR DOUBLES AND SINGLES. ALL WALK-INS WILL BE SUBJECT TO LANE AVAILABLITY.

YOU MUST BOWL DOUBLES AND SINGLES AT THE TIMES LISTED ABOVE. THERE WILL BE NO OPEN TIMES IN THE MIDDLE OF THE DOUBLES AND SINGLES SHIFTS.

BOWLERS 65 YEARS OF AGE AND OLDER MAY BOWL SEPARATE DOUBLES AND SINGLES SHIFTS.

THE SPRINGFIELD CLARK COUNTY USBC IS NOT RESPONSIBLE FOR ANY LANE CONDITIONING EQUIPMENT MANFUNCTION. THE TOURNAMENT MANAGER WILL MAKE THE FINAL DECISION ON ANY LANE ISSUES.

NOTE: THERE WILL BE ONE WARNING FOR UNSPORTSMAN-LIKE CONDUCT. TEAM CAPTAINS ARE RESPONSIBLE FOR THE TEAM MEMBERS AND GUESTS.

NO FLASH PHOTOGRAPHY. INAPPROPRIATE APPAREL OR CARDS WILL NOT BE PERMITTED DURING THE TOURNAMENT. THIS IS SUBJECT TO THE TOURNAMENT DIRECTOR'S DISCRETION.

THE SPRINGFIELD CLARK COUNTY USBC WILL NOT BE RESPONSIBLE FOR ANY INJURIES OR ILLNESSES RESULTING FROM THE ENTRANT BOWLING IN THIS TOURNAMENT.

**SPECIAL NOTE:** Prize money will be paid within 30 days as required by USBC Rules.
