SPRINGFIELD CLARK COUNTY USBC MASTERS TOURNAMENT RULES

- 1. To be eligible, entrants must be USBC members. Out of county bowlers must pay an additional \$10.00 local membership fee to participate. This is a scratch tournament. No handicap.
- 2. All entrants will bowl 6 qualifying games moving to the next pair after each game. The field will then be cut to the top 25%, 10 bowlers maximum. After the qualifying round, the field will be cut as follows:
 - a) 8-23 paid entries, cut to 4 players for match play.
 - b) 24-31 paid entries, cut to 6 players for match play.
 - c) 32-39 paid entries, cut to 8 players for match play.
 - d) 40 or more entries, cut to 10 players for match play.
- 3. All qualifiers will then bowl a single-game round robin match play against one another with the winner awarded 30 bonus pins and 15 pins each for a tie. At the conclusion of the round robin, there will a position round for all qualifiers and then the top 50% of the highest scores, 5 bowlers maximum, will bowl in the step ladder finals to determine the winner of the tournament.
- 4. In the event of a tie going into the position round, the bowler with the highest game in match play will take the higher position. If still tied, the next highest game will count and so on until the tie is broken.
- 5. In the event of a tie at the conclusion of the qualifying round, at the conclusion of match play, or in the stepladder finals, there will be a 9th and 10th frame roll-off until the tie is broken.
- 6. During match play, the bowler on the odd numbered lane will start and bowl one frame. His opponent will then bowl two consecutive frames starting on the even numbered lane.
- 7. In the event a bowler in match play is unable to compete, the alternate will take over that spot and assume scores and ranking of the bowler. The alternate must be available to bowl immediately and must stay for the conclusion of match play to be eligible for any prize money.
- 8. Dress code requirements are a bowling shirt with a "butterfly" type collar or a branded bowling shirt. Dress slacks or jeans (no cords or sweatpants) are required during all competition. Jeans and slacks must be neat and free of rips and tears. No hats or caps.
- 9. Women may wear skirts.
- 10. Please turn off all cell phones during the tournament.
- 11. Unsportsmanlike conduct as determined by the tournament committee may result in disqualification.
- 12. You must sign your score sheet!!! An incomplete, incorrect, or unsigned score sheet may result in disqualification. If you have any questions, see a tournament official.
- 13. Prize list is estimated and based on **40 Bowlers**. One in four bowlers will cash.
- 14. Re-Rack rule: One re-rack is permitted per game; others may be made at the discretion of the tournament director.
- 15. USBC rules and regulations will govern this tournament.
- 16. Lane Conditions: The Springfield Clark County Masters will be conducted on lane conditions similar to the USBC Masters Tournament. The lane conditioning equipment will be checked for the correct shot before the lanes are run each day.
- 17. The Springfield Clark County USBC is not responsible for any lane conditioning equipment malfunction or equipment breakdowns. The tournament manager will make the final decision regarding any lane issues.
- 18. The Springfield Clark County USBC will not be responsible for any injuries or illnesses resulting from the entrant bowling in this tournament.
- 19. Prize checks will be distributed on the last day of the tournament.
