SCC USBC WOMEN'S CITY TOURNAMENT RULES

- 1. Entry will be open to all female members of the Springfield-Clark County USBC.
- 2. This tournament will be a handicap tournament in the team, doubles and singles event. Handicap will be 90% of 210 scratch.
- 3. An entrant may participate in the team event **NO MORE THAN FOUR TIMES**; however, no more than three players on one team can place more than once in the prize fund. A team consists of four (4) members.
- 4. AN ENTRANT MAY PARTICIPATE IN THE DOUBLES AND/OR SINGLES MULTIPLE TIMES BUT CANNOT CASH TWICE WITH THE SAME PARTNER IN DOUBLES.
- 5. An entrant must use her highest average established in a Springfield Clark County certified league regardless of whether bowled as a league member or a substitute. Averages will be accepted in the following order:
 - a. Highest previous winter season average for at least 21 games.
 - b. If no previous winter season average, an entrant shall use her highest previous summer season average of at least 21 games. If using a sport shot average, it will be converted to a standard average.
 - c. If no 21-game average of the previous bowling season, an entrant shall use her highest current league average for at least 21 games. The bowler is responsible for getting verification to the Tournament Manager.
 - d. IF THERE IS NO VERIFICATION, THE ENTRANT MUST BOWL 210 SCRATCH.
 - e. Any discrepancy in average will be handled at the discretion of the Tournament Manager.
- 6. All-events actual/handicap is optional and the entry fee for each event is \$2.00 and/or \$4.00 per person. Optional all-events may be transferred provided the substitute replaces the original entrant in all three events and the transfer is made by the Tournament Manager or her assistants prior to time of substitute's participation in any event. If an individual who has not paid the optional all-events fee bowls the actual or handicap all-events high total score, she shall be declared the all-events champion and will be awarded the trophy, but no prize money. If an individual wins both actual and handicap, she will receive prize money if a paid entrant. When a bowler competes more than once, her first team, doubles and singles events bowled in the tournament shall count toward her all events score.
- 7. The entry fee must accompany the entry form. Entry fees shall not be refunded except when the Tournament Manager notifies an entrant of dates and times assigned and a <u>WRITTEN REFUSAL</u> has been received by the Tournament Manager <u>WITHIN 7</u> <u>DAYS OF THE DATE OF THE NOTICE</u>. There will be absolutely no changes made in the schedule except in cases of extreme emergency.
- 8. Substitutes are permitted, but the team captain must report such substitution and her average to the tournament office a half-hour before the scheduled time of bowling. Substitutes in team, doubles, and singles must bowl in the position vacated by the original entrant. No changes of line-ups will be permitted.
- 9. In case of an injury, disability or an emergency after a game has started in team or doubles a substitute will be permitted if one is available. Handicap shall be figured on the higher of the two bowlers involved with frames already bowled to count. If no substitute is available, the disabled bowler's actual score will count for the frames she has already bowled.
- 10. A bowler arriving late will be allowed to bowl and shall begin play with her scores to count beginning with the frame bowled. No pins will be allowed for missed frames.
 - a. If one bowler is late for the doubles event, the bowler present will bowl her singles event first. If her partner has not arrived by the time the singles event is finished, and an eligible substitute cannot be found, the bowler present will be permitted to bowl her games in doubles in order to qualify for all events.
- 11. Cash awards will go to the winners in the handicap division of singles, doubles, and team event only. Trophies will be presented to the first-place winners in each handicap event and first place in each actual event.
 - a. In the case of a first-place tie in any event, the team or individuals shall play off the tie to decide the winners of the award. First and second place money will be combined and divided equally. Championship awards will be given to the first-place winners in team, doubles, singles, and all-events.
 - b. If two or more teams are tied for the championship and there is a duplication of personnel on any of the teams involved there shall be no play-off, and co-champions shall be declared. If there is no duplication of personnel on the teams tied for the championship, there will be a play-off.
- 12. The team captain must report to the tournament office a half-hour before scheduled time to bowl. Bowlers in doubles and singles must check-in a half hour before bowling. Bowlers wanting to walk-in for a shift must arrive 45 minutes before the shift time to register.
- 13. Entries will be scheduled as received. Requests to cross lanes with a certain team/doubles/singles will be granted if entries are mailed in the same envelope and written request is included and provided lanes are available.
- 14. All three game events will be scheduled on one pair of lanes. There will be no more than three sets of doubles and singles on one pair of lanes, excluding breakdowns.
- 15. Team captains are to sign the recap sheets, thus giving their approval before the score sheets are turned into the tournament office.
- 16. Any protest affecting eligibility or playing rules must be confirmed in writing to the Tournament Manager before the tournament prize payments are made.
- 17. The Tournament Director, with assistance of the Springfield Clark County USBC Tournament Committee, shall decide any questions not covered by the tournament rules.
- 18. The Springfield-Clark County Championship Tournament shall be USBC certified. The prize fund will be returned 100% and there will be at least one prize for each five (5) entries or major fraction thereof in team, doubles, and singles events.
- 19. The breakdown of entry fees is as follows: Bowling Fee: \$11.00 Prize Fund: \$11.00 Expenses/Awards: \$3.00 Total \$25.00
- 20. Within seven (7) days of the completion of the tournament, the winners and their prizes shall be posted at each bowling establishment, except in the event of a tie.
- 21. A substitute will not be required to reimburse the entry fee paid nor shall the substitute be expected to give the original entrant any prize money or award she may win.
- 22. Only bowlers, monitors and tournament officials will be permitted in the bowling/settee area.
