TOURNAMENT RULES – PLEASE READ CAREFULLY

- Entry will be open to all female members of the Springfield-Clark County USBC. Unmarried students under the age of 18 must file a parental consent form.
- This tournament will be a handicap tournament in the team, doubles and singles event. Handicap will be 90% of 210 scratch.
- An entrant may participate in the team event no more than four times; however, not more than three players on one team can place more than once in the prize fund. A team consists of four (4) members.
- 4. AN ENTRANT MAY PARTICIPATE IN THE DOUBLES AND/OR SINGLES MULTIPLE TIMES BUT CANNOT CASH TWICE WITH THE SAME PARTNER IN DOUBLES.
- 5. An entrant must use her highest average established in a Springfield-Clark County certified league regardless of whether bowled as a league member or a substitute. Averages will be accepted in the following order:
 - a) Highest previous winter season average for at least 21 games.
 - b) If no previous winter season average, an entrant shall use her highest previous summer season average of at least 21 games.
 - c) If no winter or summer average, an entrant shall use her highest average of at least 21 games as of January 1 of the current bowling season.
 - d) If no 21-game average as of January 1, of the current bowling season, an entrant shall use her highest league average for at least 21 games with verification from the league secretary. The bowler is responsible for getting verification to the Tournament Manager. IF THERE IS NO VERIFICATION, THE ENTRANT MUST BOWL 210 SCRATCH.
 - e) Any discrepancy in average will be handled at the discretion of the Tournament Manager.
- 6. All-events act/hdcp is optional and the entry fee for each event is \$2.00 and/or \$4.00 per person. Optional all-events may be transferred provided the substitute replaces the original entrant in all three events and the transfer is made by the Tournament Manager or her assistants prior to time of substitute's participation in any event. If an individual who has not paid the optional all-events fee bowls the actual/handicap high all-events total score, she shall be declared the all-events champion and will be awarded the trophy, but no prize money. If an individual wins both actual/handicap, she will receive only the actual award and money if a paid entrant. When a bowler competes more than once, her first team event bowled in the tournament shall count toward her all events score.
- 7. The entry fee must accompany the entry form. Entry fees shall not be refunded except when the Tournament Manager notifies an entrant of dates and times assigned and a <u>WRITTEN REFUSAL</u> has been received by the Tournament Manager <u>WITHIN 7 DAYS OF THE DATE OF THE NOTICE</u>. There will be absolutely no changes made in the schedule except in cases of extreme emergency.
- 8. Substitutes are permitted, but the team captain must report such substitution and her average to the tournament office an hour before the scheduled time of bowling. Substitutes in team, doubles, and singles must bowl in the position vacated by the original entrant. No changes of line-ups will be permitted.
- 9. In case of an injury, disability or an emergency after a game has started in team or doubles a substitute will be permitted if one is available. Handicap shall be figured on the higher of the two bowlers involved with frames already bowled to count. If no substitute is available, the disabled bowler's actual score will count for the frames she has already bowled.
- 10. A bowler who misses one frame or more by not being present and ready to bowl when it is her turn shall not be credited with any pins for frames missed. A bowler arriving late will be allowed to bowl and shall begin play with her scores to count beginning with the frame bowled. No pins will be allowed for lost frames. If one bowler is late for the doubles event, the bowler present will bowl her singles event first. If her partner has not

- arrived by the time the singles event is finished, and an eligible substitute cannot be found, the bowler present will be permitted to bowl her games in doubles in order to qualify for all-events.
- 11. Cash awards will go to the winners in the handicap division of singles, doubles, and team event only. Trophies will be presented to the first-place winners in each handicap event and first place in each actual event. If an individual or team wins both handicap and actual trophies, she/they will receive only the actual trophy. Cash awards will go to the actual/handicap all events winner if a paid entrant.
- 12. a) In the case of a first-place tie in any event, the team, doubles, singles or all-events entrants will be declared co-champions. First and second place money will be combined and divided equally. Championship awards will be given to the winners in team, doubles, singles, and all-events.
 - b) If two or more teams are tied for the championship and there is a duplication of personnel on any of the teams involved there shall be no play-off and co-champions shall be declared. All members will receive first-place awards.
- 13. The team captain must report to the tournament office one hour before scheduled time to bowl. USBC membership cards for each member must be presented by the team captains when reporting. Bowlers in doubles and singles must check-in one half hour before bowling.
- 14. Entries will be scheduled as received. Requests to cross lanes with a certain team/doubles/singles will be granted if entries are mailed in the same envelope and written request is included and provided lanes are available.
- 15. All three game events will be scheduled on one pair of lanes. There will be no more than three sets of doubles and singles on one pair of lanes, excluding breakdowns.
- 16. The official scorer shall be selected by the Springfield-Clark County USBC. Any dispute or disagreement, or any obvious error in score shall be immediately corrected by the official scorer with the consent of the team captains and the Tournament Manager. Team captains are to sign the recap sheets, thus giving their approval before the score sheets are turned into the tournament office. No score bowled in the tournament after it has passed by the official scorer and the captain of the team or individual contestants can be changed, altered, or modified. However, the tournament office shall have full power to correct scores that show an obvious error. This does not apply to strikes and spares.
- Any protest affecting eligibility or playing rules must be confirmed in writing to the Tournament Manager before the tournament prize payments are made.
- The executive Board of the Springfield-Clark County USBC shall decide any questions not covered by the tournament rules.
- 19. The Springfield-Clark County Championship Tournament shall be USBC certified. The prize fund will be returned 100% and there will be at least one prize for each five (5) entries or major fraction thereof in team, doubles, and singles events.
- 20. Within seven (7) days of the completion of the tournament, the winners and their prizes shall be posted at each bowling establishment, except in the event of a tie.
- 21. A substitute will not be required to reimburse the entry fee paid nor shall the substitute be expected to give the original entrant any prize money or award she may win.
- Only bowlers, monitors and tournament officials will be permitted in the bowling/settee area.
