Details:

The Sugar Bear Foundation is a 501(c)(3) formed in 2016 in honor of Lieutenant Colonel Mario "Sugar Bear" Carazo who made the ultimate sacrifice while serving in Afghanistan in July of 2010. The mission of the foundation is to support Gold Star/Surviving Spouses (Active-Duty and Service-Connected losses) and their Children of fallen United States military personnel through educational initiatives focused on academic, career, and financial literacy and wellness. We provide our programming to many qualifying families throughout the United States.

We kindly request \$500 for our Virtual Education Program. This program serves Gold Star/Surviving Spouses, Children, and Teens by offering memorial scholarships, tutoring, college consulting, test preparation assistance, educational subscriptions (websites), and coaching for the mothers (spouses), to support their children more effectively in school. We provide resources and financial counseling for future planning, along with accessible workshops and supplementary materials. This program also provides educational support for children and teens who have special learning needs such as Dyslexia, ADHA, anxiety issues, etc. Our Program runs from about May through March each year.



We take a holistic approach, especially with families who are dealing with the loss of their service member. As such, this program also provides educational programming focused on health and wellness, such as workshops, video recordings, and supplemental literature.

To date, all of our Registered families consist of women and their children, and our programming aims to help these families move forward with more stability. The majority of our families are struggling both financially and emotionally. Spouses need to either secure employment or prepare to re-enter the educational arena so they can take steps toward securing better-paying jobs. These women juggle all facets of their home life, especially raising their children. We want to help remove some of these burdens while providing tangible support that will impact the whole family's future. These families would not be able to afford such comprehensive services without our programming, especially in a nurturing environment that understands the gravity of their loss. Since its inception four years ago, our Virtual Education Program has provided hundreds of hours of tutoring for children, teens, and spouses, improved test scores and grades, secured college acceptances, funded private and higher education, and provided parental support. It is one of our most utilized programs and continues to grow. We are grateful for any support.

Each year we partner with the Marine Corps Association Foundation to cohost the Sugar Bear Virtual Memorial Run and split the proceeds. We also offer t-shirts and challenge coins to any donor that contributes more than a \$40 donation. Over the years we have had various individuals and or companies hold fundraisers for us. We do not receive any government support.

We are very grateful for your consideration as we strive to give back to the families who have given their all in service to our country.

Here are some testimonials from families in this program-

- "My son would benefit from having some one-on-one help with his math work. It has become more difficult, and it is hard for me (his mom) to help him because they teach the math very differently than I learned it and I am an only parent after late husband was KIA so I am quite busy getting dinner ready, etc. when he is doing homework. He also learns better from other adults and gets frustrated with me."
- "This resource is invaluable for our teens and young adults. It is a much-needed resource in our community."



- "As a surviving military family, we live on a fixed income. I had to return to work full time to pay our bills. I cannot afford to pay for private tutors. Our public school does not offer the individual tutoring assistance my children require. As a working single parent, it's very difficult to tutor and assist my kids in subjects that are difficult for me to understand as well."

Details: During a recent trip to Sam's club \$800 was used to purchase food items and \$200 for household items (paper goods and disposable dining supplies. Once a month we shop for each of the 3 Fisher House campuses in San Antonio Texas for their "wish list" items. A shopping trip averages around \$1,000.00. The funds will be used to purchase essential grocery, pantry, and household items for military families staying at one of the three Fisher House campuses in San Antonio, Texas. These items include non-perishable food such as canned and packaged goods, disposable dining supplies including plates, cups, and utensils, as well as paper products like paper towels and toilet paper. Additionally, the funds will help procure cleaning supplies and, when needed, small household appliances such as coffee makers, hand mixers, and toasters. We conduct monthly shopping trips to fulfill the "wish list" needs of each campus, ensuring that families have access to necessary supplies during their stay. Fisher House, Inc. also provides a Taxi service for military families to critical medical appointments. These funds will directly support active duty and retired military members and their families by reducing their financial burden during their stay at Fisher Houses. By providing a well-stocked pantry, families can prepare their own meals, helping them save on dining expenses while also creating a sense of comfort and normalcy during a challenging time. Additionally, by alleviating these costs, the funds enable families to focus on their loved one's medical care and recovery without the added stress of food and lodging expenses.

The need is on-going. We entered a date in the event field because it is required, any donation of any amount and any time of the year would be greatly appreciated. Thank you for your consideration.
