 - ii) \$53K in savings account.

- a) Rules/Violations Committee (Jennifer) no update. We are working to get the website updated. Will have links to report city issues directly to them.
 - i) Dues are once a year (home owner asked). Hardcopy, will also be on website. Dues still \$125. No need to change them.
- b) ACC Committee (Jennifer) approvals are being done within 24hours. No outstanding approvals at this time. Form on website will allow you to turn in questions or concerns there.
- c) Special Projects (Amber/Liz) nothing to report
- d) Landscaping (Shawna) met with a couple landscapers and obtaining quotes so we can vote to approve the next years landscaping contract.

VI. Old Business (Shawna)

- i) Old business rediscussed overgrown landscaping in neighbors homes. HOA can talk to them about front yards but back yards falls to the city to handle. We are trying to find out what can be done to the properties, but fining isn't working so we need to look at other things like putting a liens on them.
- b) It was approved by majority of the board to wait on a neighborhood gathering.
- c) We can continue the neighborhood watch program when we obtain more volunteers.
- d) The Special Projects committee will be researching the repainting of fading and missing house numbers on the curb and will return back to the board next month with cost and times frames.
- e) If there is room for community corn hole boards, then we can entertain the idea.
- f) Homeowners will be able to volunteer for committees once HOA is back on track. The goal date is January 1st, 2023.
- g) Will the park be the next special project?
- h) We are still researching what we as an HOA can do help with neighborhood disputes such as encroaching business, trees, blackberries and weeds. As a board we ask that you try and work with your neighbors. If that does not work, we will need to contact the city. We have provided a list of numbers to contact for situational problems.
- i) Monthly Sweeping for our neighborhood is the 2nd Monday of each month.
