

## QuickBooks Online (QBO) Services Terms and Conditions

Thank you for selecting Rockland Professional Services, LLC (d.b.a., "Rockland Pros") to assist you with QuickBooks Online (QBO) Services. The following Terms and Conditions outline the nature and scope of the QBO Services we provide. When you engage Rockland Pros, you acknowledge and agree to the Terms and Conditions of our QBO Services.

### 1. QBO IMPLEMENTATION SERVICES.

Rockland Pros offers three (3) distinct QBO Implementation Service Packages. Rockland Pros will charge Client for professional service fees based on the Implementation Service Package selected, plus any additional Add-On Services selected.

#### 2. QBO LICENSES & SUBSCRIPTIONS.

- a) QBO license(s) offered to Client by Rockland Pros will be obtained by Rockland Pros directly through Intuit. In accordance with our agreement with Intuit, Rockland Pros is legally and financial responsible its QBO license(s).
- b) Rockland Pros will sub-lease its QBO license(s) to Client for a subscription fee. In accordance with Client's agreement with Rockland Pros, Client is legally and financial responsible for remitting payment to Rockland Pros.
- c) Rockland Pros and Client are both subject to Intuit's Terms of Service, which are made available on the the software vendor's website. [https://quickbooks.intuit.com/software-licenses]

#### 3. COMPENSATION.

a) <u>QBO Implementation Services</u>: Rockland Pros will implement QBO for Client in accordance with the subscription package selected in Section 1, as outlined in Appendix A.

Rockland Pros will use commercially reasonable efforts to complete the implementation in accordance with the terms and conditions herein. Client acknowledges that despite these efforts Rockland Pros's work is highly dependent on Client, Intuit (software vendor), QBO (software), and other factors beyond the control of Rockland Pros. If one or more of these factor should cause a significant impact to this project, Rockland Pros will contact Client immediately to advise and to obtain agreement with Client on an appropriate course of action.

Client will compensate Rockland Pros for its professional services.

b) <a href="QBO Subscriptions">QBO Subscriptions</a>: Rockland Pros will provide access to its QBO licence(s) to Client; Client will compensate Rockland Pros with a monthly subscription fee based on the version of the software selected.

#### 4. TERMINATION.

- a) Client or Rockland Pros may terminate the use of QBO Subscriptions for any reason or no reason upon thirty (30) days advance written notice to the other party.
- b) Rockland Pros may terminate QBO Subscriptions with or without notice for non-payment or insufficient payment. Termination due to non-payment or insufficient payment by Client will result in immediate termination of Client's access to the QBO by Rockland Pros. Client acknowledges that this action may result in permanent deletion of their data.
- c) Client acknowledges that the QBO Subscriptions offered to Client by Rockland Pros are offered exclusively to Rockland Pros' clients; termination of QBO Subscriptions does not entitle Client to the subscription fees offered through Rockland Pros.
- d) Upon termination, Client will need renew their subscription directly through Intuit, if they require access to their QBO file.
