

Swim at Your Own Risk both with and without Gate Attendants present.
There are NO Lifeguards on duty. Gate Attendants are Not Lifeguards.

- See Waiver of Liability – all members are required to read, complete and sign. If you have not signed a Waiver, please ask the Gate Attendant for one or email CastleHillsForestHOA@gmail.com for a copy. It is also on the CHF website under the Pool tab at the bottom.
- **In case of Emergency Dial 911: 13750 GEORGE ROAD**
- Glass items and/ or weapons not allowed in pool area.
- **Children under 12 must be accompanied by an adult 16 or over.** Children under 12 will be asked to leave and return with an adult.
- Baby pool is for 5 and under. Children who are not yet potty trained must be in a Swim Diaper
- Changing diapers within 6 feet of the pool is prohibited
- No smoking or vaping within 50 feet of the gated pool area
- Diving only allowed in 9' foot deep end. NO diving in the shallow end or baby pool.
- Do not stand on, climb, or jump off of the Lifeguard stand
- No running, dangerous horseplay or rowdy behavior. No profanity or inappropriate behavior.
- No loud music
- Must wear swimsuits that provide appropriate coverage. No swimming in regular clothing.
- Do not sit, play with, or hang on the lane lines.
- Pets in the pool area are prohibited – Service dogs are the exception.
- Members are allowed up to **3** guests per visit and member must be present. (fee of \$5 applies per guest after the first 3. It is an honor system. Please pay the Gate Attendant or HOA will accept PayPal and Venmo)
- Please clean up after yourself and return any CHF HOA pool toys borrowed.
- Respect your neighbors. This is your community!
- Members can use the pool during Posted Pool Hours ONLY. There is no use of the pool while SA Wave or CHF Eels are present.

3. Third Offense: Removal of access to pool area with no expectation of a refund of Pool Membership fees.
