In this Privacy Policy we, us or our means BE OMG Australia PTY LTD (ACN 635 064 989) trading as Refresh Your Mind.

Who we are This website is owned and operated by Angelique Pellegrino and managed by herself and her team. We respect your privacy.

Angelique Pellegrino respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. This policy sets out how we collect and treat your personal information. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth) and to the extent applicable, the EU General Data Protection Regulation (GDPR).

"Personal information" is information we hold which is identifiable as being about you.
