



## CORNSTOCK FAQ/Rules – SEPTEMBER 26-27, 2025

1. **Know the Rules.** Please read our policies prior to attending the event and check the official Cornstock-Anderson County Corn Festival website for detailed information. We kindly ask you to respect our volunteers and adhere to special policies from the artist or tour.
2. **Pack Light.** Do not attempt to bring prohibited items into the venue. Please check the “FAQ – Things to Know” link on our website for items you are permitted or not permitted to bring into for the event you are attending. All items are subject to being searched before entry. FAQ - No outside food or beverages of any kind are permitted in the festival area. Our policy is CLEAR BAG OR SEARCH.
3. **Be Respectful.** Be the fan that others want to be around. Your decisions and actions impact those around you. Allow fans of all ages to have a positive experience and please refrain from inappropriate & disruptive behavior.
4. **Follow directions from staff.** Safety of everyone is at the top of our list. Our Staff members are your resource for information regarding venue operations, rules, and emergency procedures.
5. **Concert wristbands must be worn at all times.** Occupying the park or campground requires a ticket or wristband. You may be asked to present your ticket or wristband at any time the day of the event. Wristbands are to be worn securely on your wrist.
6. **Weather Plan.** Please visit our website for details regarding policy in the event of inclement or severe weather.
7. **Standing vs. Sitting.** It can be difficult to determine whether you should stand/dance or sit during an event, so please observe the behavior of the majority of those around you and please act appropriately.
8. **Drink Responsibly.** Event staff reserves the right to and will deny entrance to impaired/intoxicated guests. Persons impersonating a legal adult (fake ID) or caught underage drinking anywhere in the park will be ejected in a prompt and safe manner. Tailgating is prohibited.
9. **Unauthorized Vending is Prohibited.** It is illegal to sell food, alcohol, tickets, or any other items in the parking lots, campgrounds and in the venue. Violators will be ticketed and/or removed from the premises.
10. **Have fun & enjoy the event!** With your help, we can provide a memorable experience for ALL fans at **Cornstock**.

**Camping at Cornstock:** Campsites within the City of Garnett parks must be reserved in advance through the Garnett Parks & Recreation link on [www.campspot.com](http://www.campspot.com). No campers will be allowed in without advance reservations.

**Friday Night Happenings:** There is a Cornhole Tournament in the campgrounds at Lake Garnett, located near the East Shelter on Friday, September 26. Registration is 4 to 5:30 p.m. Play begins at 6 p.m. Cash, Meet and Greets, Kicker Audio gear and other prizes awarded. Information is provided in your welcome packet.

**CORNSTALKING:** Members of the Anderson County Corn Festival may visit random campsites and concert area, and surprise visitors with free prizes, including t-shirts, meet and greets, artist merchandise and gifts provided by sponsors. Please note, you may be videoed or photographed to be shown on event social media.

**Shuttle Bus:** Courtesy shuttle bus transportation will take campers to the main gate of the concert area. Buses will arrive at campground designated bus stops beginning at approximately 2:30 p.m. and will continue throughout the evening taking people to and from campsites and parking areas until the end of the concert. No alcohol consumption on bus.

**HANDICAPPED:** Limited handicapped parking is available for those vehicles displaying the handicapped emblem on their license plates. A shuttle bus with lift access is available from the handicapped parking area to the concert entrance gate.

**WEATHER PLAN:** Please visit the “FAQ – Things to Know” link on our website for instructions. This is a rain or shine event. In the event of rain, it is your decision to stay or leave the venue. In the event of severe weather, tune in to local radio stations and our Facebook page ([@accornfest](https://www.facebook.com/@accornfest)) for event plans. You may be asked to “evacuate the concert area and seek shelter”. In the event this happens it is up to you to determine and take the appropriate action immediately for your safety. The event will be in a holding pattern should the need arise with further instructions to be determined by the event and performers. Again, stay tuned to local radio stations and official event social media for more information.
