Amelia Baptist Church Joint Committee Report

Meeting Report – Representatives from Buildings, Facilities & Grounds, Deacons, and Directors met with representatives from Orchard Homeschool Fellowship, a Christian homeschool cooperative on March 24, 2022.

Those attending included John Burton, Marvin James, Wes Eary, Barry Layman, Roger Morgan, Pastor J.D. Moore and Erin & Matthew Gowin of Orchard Homeschool Fellowship.

The purpose of the meeting was to review their request to use the Amelia Baptist Church building and facilities for their periodic family meetings and homeschool sessions.

Discussion:

They are a licensed and insured LLC 501c3 nonprofit Christian cooperative.

Insured by Great American Insurance Company. They would be the primary insurance provider. The church would become the secondary provider.

They would meet the 1st & 3rd Fridays, September through May, from 10am – 2:35pm, and occupy up to seven (7) classrooms. (Nursery through 12th grade)

They schedule a Parent Support Meeting on the evening of the 2nd Friday monthly, during sessions. They assume responsibility for preparation set up, take down & cleanup.

We conducted a tour of church facilities. They were excited with what we have to offer in order to meet their needs.

Parents attend and teach classes. These are not core classes, but elective classes. Schedule, statement of faith, policy and procedures are available for all to review.

Path Forward:

We will provide this report for the April 13th business meeting.

Deacon and Director representatives will discuss with their respective groups and provide a consensus recommendation/statement for the church.

Provide (publish) the use of facilities request details (Orchard Homeschool information package). We agreed to provide a response to their request following our June 15 business meeting. And would like to respond quicker as their request is very time sensitive.
