## SEQUOYAH FOOTBALL CLUB LIABILITY WAIVER

### RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND, WHERE APPLICABLE, PARENTAL CONSENT AGREEMENT ("AGREEMENT")

In consideration of being permitted to participate in any way in the soccer activity ("Activity") I, for myself for personal representatives, assigns, heirs, and next of kin:

1. Acknowledge, agree, and represent that I understand the nature of soccer activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. Fully understand that: (a) **SOCCER ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS")**; (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the "Releasees" named below; (c) there may be other Risks and social and economic losses either not known to me or not readily foreseeable at this time; I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY for losses, costs, and damages I incur as a result of my participation or that of the minor in the Activity.

3. Hereby release, discharge, and covenant not to sue **SEQUOYAH FOOTBALL CLUB**, their respective administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owner and lessor of premises on which the Activity takes place, (each considered one of the "Releasees" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES on my account caused or alleged to be caused in whole or in parts by the negligence of the Releasees or otherwise, including negligent rescue operations and I **FURTHER AGREE** that if I, despite the **RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**, or anyone on my behalf, makes a claim against any of the Releasees I will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

**I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.**

# CODE OF CONDUCT

For Officials/Coaches/Players/Parents/Spectators

The purpose of Sequoyah Football Club is to promote the physical and social development of our players. Essential to the success of this purpose is to embrace the values and practices of good sportsmanship and conduct ourselves in a positive manner. It is the responsibility of the adults involved to be models of this behavior and lead by example by demonstrating fairness, respect and self-control. Governing acceptable behavior includes, but is not limited to, the following rules.

I will not engage, encourage my child, or any other person, to:

- Engage in unsportsmanlike conduct with or behavior which would endanger the health, safety or wellbeing of any official, coach, player, or spectator.
- Use or be under the influence of any drugs or alcohol while at Sequoyah FC events.
- Engage in any use of profanity.
- Treat any official, coach, player, or spectator disrespectfully regardless of race, creed or color.
- Engage in verbal or physical threats or abuse aimed at any official, coach, player, or spectator.
- Initiate a fight or scuffle with any official, coach, player, or spectator.

By signing, you are agreeing to conduct yourself as outlined above and acceptance of any disciplinary action for failure to comply, including but not limited to the following in no particular order:

- Verbal warning.
- Immediate ejection from the event.
- Suspension from the team.
- Ban from future attendance.
