Security Patrol

Lieutenant Smith and Captain Pimentel arrived in the designated district and initiated a thorough patrol using a marked patrol vehicle. The primary objective was to familiarize ourselves with the district layout as outlined in the provided map and assess key areas for ongoing activity and potential security concerns.

Patrol efforts began with a perimeter sweep, covering all major boundary lines and internal streets. Special attention was given to areas identified as high-traffic or high-risk, including the Youth Center, Sunland Liquor, and the intersection of El Camino and Del Paso Boulevard. These locations were noted for elevated activity and will remain focal points in ongoing patrol operations.

Initial observations helped establish a foundational understanding of the district's geography and activity patterns. Further patrols will refine route efficiency and enhance our presence in areas requiring increased visibility and deterrence.

During the hour we foot patrolled around the following business.

- Shell station/Weinerschintzel where we removed 1 white homeless male adult loitering, see photo.
- -Mcdonalds finding 1 white Ford explorer Plate number 7AS7613, see photo, with a white female loitering in the parking lot. When we found her she was asleep in the driver seat. She stated she made a mobile order though she could not provide a receipt. We spoke to the manager of the Mcdonalds who confirmed she had no order and we advised the female to vacate. She left without incident.
- -Behind 2501 Del Paso blvd there was a Black male transient inside the fence line attempting to take wood from a dumpster area. We advised him to stop and removed him from the area. The back fence of the address is completely unsecured. We also found Graffiti along the side of the building and the back. See photos.
- -At the Oreileys center we found multiple transients at the back of the business, see photos. We removed all without incident.
- -At 2213 Del Paso blvd we removed 1 black male adult transient loitering in front of the business access point, see photo.

We advised him we were just trying to keep the fire out to prevent it from spreading. He continued to be hostile, claiming to be law enforcement and approaching us with large pipe or stick. We vacated the area proceeding to the front of the business and contacted Law enforcement.

Law enforcement arrived around 325am and we explained the situation. We then proceeded with Sac PD to the alley. They contacted the subjects and advised tbsm to leave and put out the fire. Sac PD stated the alley was public so they could take no further action and vacated the area.
