Officer Johnson arrived within the del paso partnership and proceeded to conduct an initial inspection through all eight zones of the district.

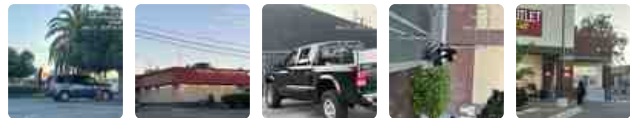
The districts were heavy with activity. Although no unwanted activity or security issues were seen during the initial inspection of all other boundaries and zones of the district.

 - Grocery Outlet on Del Paso Blvd made contact with x1 individual on property and advised him to leave and he left without incident see photos.

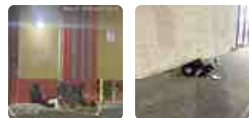
