Disposition

I, OFFICER SWONGER, ARRIVED AT THE SERVICE CALL ON DEL PASO BLVD. I FOUND THE VEHICLES IN DESCRIPTION PARKED IN FRONT OF THE 2503 DEL PASO BLVD. I WENT OVER TO MAKE CONTACT AND FOUND APPROXIMATELY 4-6 INDIVIDUALS LOITERING AROUND OR IN THERE VEHICLES. I TOLD ALL THE INDIVIDUALS THEY NEEDED TO LEAVE THE PROPERTY BECAUSE ONE OF THE BUSINESSES CALLED AND WANTS YOU GONE. THE INDIVIDUAL SAID HES GOING TO CALL THE OWNERS THEN AND SHOW THEY CAN BE HERE. I SAID I DONT CARE WHAT YOU SAY, YOU MUST LEAVE THE PROPERTY AT THIS TIME. THE INDIVIDUAL STARTED RECORDING ME WHILE OTHERS STARTED YELLING AND MAKING THREATS TOWARDS ME. INSTEAD OF CONTINUING TO ARGUE, I WALKED BACK TO MY VEHICLE AND CALLED SACRAMENTO POLICE DEPARTMENT. THE INDIVIDUALS ALL DROVE OFF OF THE PROPERTY WHILE I WAS ON THE PHONE WITH THE POLICE.

The districts were heavy with activity. Although no unwanted activity or security issues were seen during the initial inspection of all other boundaries and zones of the district.

Loitering **Transient Activity**

FTO Schroeder resumed patrol of the district patrolling through Zones 1 and 4. During the hourly inspection of the zones I found the following issues:

- 2517 Del Paso Blvd (McDonald's): Contacted a Hispanic female adult loitering in front of the business (see photo). She was advised to gather her belongings and depart from in front of the property. She was compliant and left without incident.

- 2421 Del Paso Blvd (O'Reilly's): Contacted two transient subjects, a black male adult and a black female adult, loitering in the loading

dock area (see photos). I advised them to leave the property. They were compliant and left without incident.

- 1914 Del Paso Blvd: Contacted a white female adult accompanied by a dog that had a camo set up along the fence line of the property. She was advised where to move to and was compliant.

- 1604 Del Paso Blvd: Contacted a white male adult with a shopping cart full of their belongings in front of the business. I advised them to depart from the property and where they would be permitted. They were compliant and left without incident.

- 2000 Del Paso Blvd (Sunland Liquor): Contacted a black male adult transient subject, wearing a red shirt and blue jeans, who was loitering in front of the business (see photo). He was advised to depart from the property and not return. He was compliant and left without incident.

FTO Schroeder resumed patrol of the district patrolling through Zones 5 through 8. During the hourly inspection of the zones I found the following issues:

- 1100 Del Paso Blvd: Observed a suspicious vehicle, a white Ford Econoline van (CA LP# 25220R3) parked in the parking lot next to SN&R. I proceeded to contact a black female adult, wearing all red, accompanied by a large dog in the vehicle. They stated that the dog had defecated on their bed. They stated that they had just finished cleaning the bed. I advised them to depart from the property. They were compliant and left without incident.

FTO Schroeder resumed patrol of the district patrolling through Zones 1, 4, and 7. During the hourly inspection of the zones I found the following issues:

-2109 Del Paso Blvd (N. Sac Hagginwood Library): Contacted two transient subjects loitering in front of the entrance door. I advised them to leave the front of the property. The white male adult, wearing a red plaid shirt and accompanied by a large dog (see photo), was argumentative and initially refused to leave. After advising that I would contact the Sacramento Police Department, he was compliant and left with the other transient subject.

- 2431 Del Paso Blvd (La Placita): Contacted a black female adult transient subject that was sitting in front of the business. I advised her to depart from the property. She was argumentative but compliant and left without incident.

- 2421 Del Paso Blvd (O'Reilly's): Observed a suspicious vehicle, a silver Dodge Magnum (CA LP# 6BWB568) parked on the side of the business. I contacted the occupant, a black male adult, and advised him to depart from the property. He was compliant and left without incident.

- 2456 Rio Linda Blvd (La Jerezana Bakery): Contacted a white male adult transient subject sitting on the side of the business. I advised him to depart from the property and was compliant.

FTO Schroeder resumed patrol of the district patrolling through Zones 1 through 3.

During the hourly inspection of the zones I found the following issues:

- 864 El Camino Ave: Contacted two transient subjects, a white male adult and a black male adult, that were observed loitering in front of the business. The white male left the property shortly after making contact. The black male adult had a shopping cart full of belongings that were also placed all over the ground. I advised the black male adult to gather their belongings and where they would be permitted. The male slowly gathered their belongings and departed the property.

- 765 El Camino (Bank of America ATM): Observed a black female transient subject sitting near the ATM with her belongings placed around her. I advised her to move to the public sidewalk. She was argumentative but compliant and left without incident.

-830 El Camino Ave (Dollar Tree): Observed a Hispanic male adult with a bike and large white and orange bags in the rear of the building near the dumpster. I contacted the subject and advised them to leave the property. The male was compliant and left without incident.

FTO Schroeder resumed patrol of the district patrolling through Zones 1, 4, 6, and 7.

During the hourly inspection of the zones I found the following issues:

- 2517 Del Paso Blvd (McDonald's): I observed an occupied vehicle, a black Subaru (CA LP# 7JZR934), in the rear corner of the parking lot. I proceeded to contact the two occupants, both Hispanic male adults, and inquired as to why they were on the property of a closed business. They stated they were resting for a bit. I advised them to depart from the property. They were compliant and left without incident.

- 2533 Del Paso Blvd (La Victoria): Contacted a black male adult transient subject attempting to sleep in front of the business. I advised the subject where they would be permitted to be. They were compliant and left the property without incident.

- 2507 Del Paso Blvd: Observed a grey Ford Flex (CA LP# 8VKH537) that was occupied with a white male adult sleeping in the driver seat. I proceeded to contact the male and advised him where he would be permitted to sleep in his vehicle. He was compliant and left the property.

FTO Schroeder resumed patrol of the district patrolling through all zones.

During the hourly inspection of the zones I found the following issues:

- 2507 Del Paso Blvd: Observed the Ford Flex that had left the property earlier parked on the property again. I proceeded to contact the occupant, a white male adult, who was asleep in the driver seat. After advising him to leave the property once again, he was argumentative but compliant and left without incident.

2517 Del Paso Blvd (McDonald's): Observed a white male adult sitting near a tree in the parking lot. I contacted the subject and advised to depart from the property. They were compliant and left without incident.

FTO Schroeder resumed patrol of the district patrolling through all Zones. During the hourly inspection of the zones I found the following issues:

- 1120 Del Paso Blvd (SN&R): I was flagged down by a white female adult in the parking lot of SN&R. She stated that her front passenger tire was flat on her grey Toyota Camry and she was unable to put on the spare tire due to an issue with the tire. She stated that she left notes on the dash of the vehicle and would return in the morning to remove the vehicle from the property. I advised her that I could not guarantee that the vehicle would not be towed by the contracted towing company, but that I would not notify the tow company myself. She then departed in an Uber.

-2202 Del Paso Blvd: Observed a transient subject sleeping near the doorway to the building. I contacted the transient subject, a black male adult, and advised them to depart from the property and where they would be permitted. They were compliant and left without incident.

-899 El Camino Ave (Carl's Jr.): Observed a black Ford Escape (CA LP# CR592DP) parked in the parking lot. I proceeded to contact the driver, an older black male adult, and also observed a black male adult in the rear passenger seat. As I was advising the driver I leave the property, the male passenger exited the vehicle (see photo). As he walked by, I observed a small bag with what appeared to be a white crystalline substance in his left hand. As he was about to walk off of the property, he stated that he had to urinate and began to look for an area to urinate on the property. He was advised numerous times not to urinate on the property or he would be arrested for indecent exposure. The male proceeded to pick up a plastic cup and re-entered the back seat of the vehicle. The vehicle then departed the property.

- 800 El Camino Ave (A to Z Market): Observed a white Toyota Camry parked in the parking lot. I proceeded to contact the driver. The driver stated that they were a DoorDasher and that their dash had ended approximately 10 minutes prior to being contacted. They were advised to leave the property and were compliant.

Suspicious Vehicle **Transient Activity**

FTO Schroeder resumed patrol of the district patrolling through all Zones. During the hourly inspection of the zones I found the following issues:

- 2517 Del Paso Blvd (McDonald's): I observed a silver Nissan Altima parked between the rear of the building and the dumpster area. I proceeded to contact the driver, an Asian female adult, and inquired as to why she was on property. She stated she was utilizing the WiFi to communicate with her significant other who she was arguing with. I advised her that she would have to leave the property. She was understanding and compliant.

- 2400 Del Paso Blvd (Shell): I was flagged down by a black male adult wearing a red hat, black jacket, and blue jeans (see photo). Upon contacting the male, he claimed that a black female adult wearing a black hat, blue shirt, and black pants (see photo), had stolen items from him and placed them in a reusable plastic bag. As I attempted to gather further information, the male subject repeatedly stated that he no longer wanted assistance. I then advised both subjects to leave the property. Both subjects were compliant and left without incident.
