MEETING MINUTES

CLOSED SESSION

The Del Paso Boulevard Partnership Board of Directors Closed Session Meeting for Wednesday, April 10, 2019, was called to order by the Chairman, Shane Curry at 8:04am. The meeting was held at Artspace1616, 1616 Del Paso Boulevard, Sacramento.

REGULAR SESSION

The Del Paso Boulevard Partnership Board of Directors Regular Session Meeting for Wednesday, April 10, 2019, was called to order by the Chairman, Shane Curry at 8:40am. The meeting was held at Artspace1616, 1616 Del Paso Boulevard, Sacramento.

<u>ANNOUNCEMENT</u>

The Board of Directors have accepted the resignation of the Executive Director, David Plag, effective April 1, 2019. He will continue on until June 30, 2019 to allow for a smooth transition to a new Executive Director.

<u>WELCOME</u>

CONSENT CALENDAR

The Board moved and seconded a motion to approve the minutes for March 26, 2019. The vote was unanimous.

AGENCY UPDATE REPORT

Sacramento Police Department Update

Police Lt. Rudy Chan addressed the Board and talked about the new fencing for the El Camino Avenue/Darina Avenue Alley, the new cannabis grows in the area and the problems with security at the Grocery Outlet.

Paladin Private Security Update

Officer Godard discussed the stats for the district, which compares the month of April 2017 to April 2019. There was a noticeable decrease in Missing Persons and Prostitution, there was a marginal decrease in Fire, Illegal Dumping, Narcotics Activities, Alarm Activations and fights. There was, however, a noteworthy increase in Disturbed Persons, Unlawful Camping and Vandalism.

Oversite Board, RASA Update

Leslie Fritzsche talked about the available RASA properties on the Boulevard, including the 90 day ERN for the 1400 Block of Del Paso Boulevard.

ACTION ITEMS

A. Executive Search Committee

With the Executive Director stepping down, an Executive Search Committee needs to be established. The Chair ask for volunteers and appointed Dave Veden, Deneb Williams and Charlie Tiwana. Shane Curry will serve as an alternate. A motion was forwarded and second to appoint Dave Veden, Deneb Williams and Charlie Tiwana to serve on the Search Committee with Shane Curry as an alternate. The motion was approved with a unanimous vote.

B. 2019 Assessment Rate CPI Increase

The Management District Plan allows for an increase in the assessment rate each year of up to 3%. The Partnership has never increased its assessment rate since it was established in 2005. After a discussion by the Board, it was moved and seconded to

increase the assessment rate 2.5% in 2020. The vote was approved with a vote of 7 yeas and 2 nays.

C. Board Nominating Committee

The Vice Chairman for the Nominating Committee, Dave Veden, tabled the item. No vote was taken.

D. 2019 PBID Budget

The PBID budget was presented to the Board. After a brief discussion, the Board moved and seconded a motion to approve the 2019 budget. The vote was approved with a vote of 8 yeas and 1 nay.

ADMINISTRATIVE REPORT

Executive Director

David gave his Executive Director's report and talked about the CHW meeting on March 26, the Annual Spring Carnival scheduled for April 24 – 28, and the grant awarded to the Partnership by the City's Department of Utilities Stormwater Management Program.

David gave an update on the development of businesses and property on the Boulevard and the cannabis grow facilities in the PBID/BIA.

The Board moved and seconded the Executive Director's report. The motion was approved with a unanimous vote.

<u>INFORMATION ITEMS</u>

David talked about some of the 14 Information Items in the packet, including the Kim Scott reception at Artspace1616, the adult Easter Egg Hunt at the Stoney Inn and the Juke Joint event at the Rink Studios.

COMMITTEE REPORTS

A. Treasurer's Report

David did a review of the three PBID bank accounts. The PBID has approximately \$158,212 on hand with all bills paid.

PUBLIC COMMENTS

John Blair asked about the Wide Open Walls event on the Boulevard.

Adrian Perez talked about a marketing campaign for the Boulevard as well as a Broker's meeting.

Franklin Burris, with the North Sacramento Chamber of Commerce, talked about his events in April and early May.

Mina Perez talked about the events they are doing in April and moving the Taco Festival to the U-Haul location on Arden Way.

NEW BUSINESS / OPEN FORUM

The next PBID Board meeting is scheduled for Wednesday, May 8, 2019, with a location to be determined.

A motion to adjourn the meeting was seconded and approved with a unanimous vote. The meeting was adjourned at 10:44am.
