MEETING MINUTES

CALL TO ORDER

The Del Paso Boulevard Partnership Board of Directors meeting for Wednesday, February 12, 2019, was called to order by the Chairman, Shane Curry at 8:40am. The meeting was held at Artspace1616, 1616 Del Paso Boulevard, Sacramento.

ROLL CALL

PRESENTATION

Rick Eaton, Chairman of the North Sacramento Development Corporation, addressed the Board and spoke about the development of the NSDC and the goals to improve the North Sacramento area.

AGENCY UPDATE REPORT

Sacramento Police Department Update

Police Lt. Rudy Chan addressed the Board and spoke about the shift change in the North Command, the armed robbery at the Arden Way Chevron and the crime stats for the area.

Paladin Private Security Update

Andrew Duncan discussed the stats for the district, which compares the month of January 2017 to January 2019. There was a noticeable decrease in Disturbed Persons, Robbery, Threat and Welfare checks. There was a marginal decrease in Fire, Lewd Conduct, Narcotic Activities and Quality of Life issues. There was, however, a marginal increase in Intoxicated Persons and Vandalism.

Oversite Board, RASA Update

Leslie Fritzsche talked about the available RASA properties on the Boulevard, including the 1400 and 1000 Block of Del Paso Boulevard.

ACTION ITEMS

Pat Wyluda, Chair of the Nominating Committee, discussed the three seats that are vacant, the applicants who applied for those seats and the Nominating Committee's recommendation.
