MEETING MINUTES

CALL TO ORDER

The Del Paso Boulevard Partnership Board of Directors meeting for Saturday, January 12, 2019, was called to order by the Chairman, Shane Curry at 9:13am. The meetings were held at the Embassy Suites, 100 Capitol Mall, Sacramento.

ROLL CALL

Present – Shane Curry, Pat Wyluda, Charlie Tiwana, Leslie Fritzsche, Jay Roth, Larry Taylor and Mimi Martinez. Deneb Williams and Kevin Lutz came late.

One vacancy on the Board

Staff - Executive Director, David Plag and Communications Director, Larry Groves were present.

ACKNOWLEDGEMENTS

The Chairman, Shane Curry, acknowledge the 100% attendance record of Daniel Savala and Charlie Tiwana, and the 92% attendance record of himself and Larry Taylor.

Shane also congratulated Larry Taylor, who is stepping off the Board, with a glass plaque for his four years on service to the Board and the community.

PRESENTATION

Brian Ostrovsky made a presentation about Locable, a local software product that ties a single event to multiple sites with cross promotion and marketing. He also mentioned holding classes to help individual businesses in the PBID to learn how to use the product effectively.

CONSENT CALENDAR

The Board moved and seconded a motion to approve the minutes for November 29, 2018. The vote was unanimous.

AGENCY UPDATE REPORT

Sacramento Police Department Update

Mark Scurria introduced himself as the new Sergeant for the North Area. He talked about the increase burglaries in the area, including car and business thefts. Deneb mentioned the number of car break-ins he has had in the last six months. Sgt. Scurria also talked about the effort by the community to shut down the Poly Urban Studios on Boxwood.

Paladin Private Security

Matt Carroll discussed the stats for the district, which compares the month of December 2016 to December 2018. There was a noticeable decrease in Disturbed Persons, Robbery, Threat and Welfare checks. There was a marginal decrease in Lewd Conduct, Narcotic Activities and Quality of Life issues. There was however, a marginal increase in Intoxicated Persons and Vandalism.

The Board ask questions of Matt about some of the issues in other districts and the ability of Paladin's to resolve those issues.

ACTION ITEMS

A. Board Nominating Committee

Pat Wyluda, Chair of the Committee, discussed the three seats that are vacant, the applicants who applied for those seats and the Nominating Committee's recommendation.

After a long discussion, Board voted, 4 ayes to 3 nays, to table the entire Action Item until next month and have the five resumes sent to full Board.

ACKNOWLEDGEMENTS

Kevin Lutz, who arrived late, is stepping down from the Board, was congratulated by the Chairman with a glass plaque for his five years on service to the Board and the community.

<u>ADMINISTRATIVE REP</u>ORT

Executive Director

David gave his Executive Director's report and talked about the grant that was awarded to the Partnership by a local utility company, the success in closing down the Poly Urban Studios and the opening of the new Golden Blades Barbershop at 2100 Del Paso Boulevard

David gave an update on the development of businesses and property on the Boulevard, as well as the cannabis grow facilities in the PBID/BIA, and an update to the temporary homeless shelter on Railroad Avenue.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.

David talked about some of the 22 Information Items in the packet, including the artist reception at Artspace1616 on January 12, the Cannabis Neighborhood events and the Martin Luther King, Jr. March on January 21.

COMMITTEE REPORTS

A. Treasurer's Report

David did a review of the three PBID bank accounts. The PBID has approximately \$62,971 on hand with all bills paid except one.

PUBLIC COMMENTS

Howie Ditkof, owner of Steam Cleaners, Inc., wanted the know more about the PBID and the Partnership works.

Elsa Romo discuss the PBID's position regarding her cannabis grow facility on Boxwood and why the Partnership was not supportive of the efforts.

Noelle Davis talked about supporting small businesses and mentioned her effort with the Craft Faire on the Boulevard in December.

Pay Sayer-Handley mentioned, as President of the Friends of the Library, that they are in support of moving into the Limn Building on Arden Way.

NEW BUSINESS / OPEN FORUM

The next PBID Board meeting is scheduled for Wednesday, February 13, 2019, with a location to be determined.
