#### **MEETING MINUTES**

#### ROLL CALL

#### **PRESENTATION**

David Sobon, with Wide Open Walls, presented to the Board a request to do five walls in North Sacramento as part of the 2019 WOW event, August 7 – 17. Councilmember Warren has committed \$25,000 and WOW will be requesting \$25,000 from the Partnership.

#### **CONSENT CALENDAR**

The Board moved and seconded a motion to approve the minutes for February 13, 2019. The vote was unanimous.

#### AGENCY UPDATE REPORT

### Sacramento Police Department Update

Police Lt. Rudy Chan addressed the Board and spoke about the new gate that will be put in the alley behind El Forastero Restaurant and Ambrosia Catering.

### **Paladin Private Security Update**

A Paladin representative was available for the meeting, but David Plag address the Board and spoke about the stats for the district, which compares the month of February 2017 to January 2019. There was a noticeable decrease in Narcotics Activity, a marginal decrease in Welfare Checks and a noteworthy increase in Alarm Activations, Disturbed Person, intoxicated Persons, Theft, Quality of Life Issues and Unlawful Camping.

## Oversite Board, RASA Update

Leslie Fritzsche talked about the available RASA properties on the Boulevard, and the ERN agreement with Tommy Young with the Launchpad property at 1400 Del Paso Boulevard.

#### **ACTION ITEMS**

## A. Recommendation from Cannabis Grow Facility Sub-Committee

After a short discussion, the Board moved and seconded a motion to approve the cannabis marijuana grow facility at 2020 Railroad Drive. The vote was 7 yeses to 1 abstention.

### **ADMINISTRATIVE REPORT**

#### **Executive Director**

David gave his Executive Director's report and talked about the \$1.3 million from the City to help restore Iceland Ice Skating Rink. He also mentioned the opening of Golden Glazes Barbershop at 2100 Del Paso Boulevard and SACOG will be having their Civic Lab at the Artisan on 3/20.

David gave an update on the development of businesses and property on the Boulevard, as well as the cannabis grow facilities in the PBID/BIA. He also mentioned Woodlake Tavern's new roof over the outdoor seating area.

The Board moved and seconded the Executive Director's report. The motion was approved with a unanimous vote.
