## **CALL TO ORDER - REGULAR SESSION**

The Del Paso Boulevard Partnership Board of Directors meeting for April 11, 2018, was called to order by the Chairman Shane Curry at 8:36am. The meeting was held at Artspace 1616, 1616 Del Paso Boulevard, Sacramento.

#### **PRESENTATION**

Mike Tate presented his 1615 Project on the Boulevard. Mike is opening art studios and has signed a few artist but needs additional funds for signage on the building. Mike is asking for \$1,000 for his project.

Because it was not an action item, the item could not be voted on directly. The Board moved and seconded a motion to have the item addressed with an email vote. The motion passed with a unanimous vote.

An email was sent to the Board on April 12th. The Board approved the funding of \$1,000 for the 1615 Project on April 13 with a 6 - 0 vote.

# Sacramento Police Department Update

Sergeant Jeremy Schwartz introduced himself and talked about the helicopter activity on Tuesday evening over Del Paso Boulevard. He mentioned the new bicycle patrols on the Boulevard and the value it brings to the area.

## **Paladin Private Security**

Matt Carroll was not able to attend the meeting, but did express his concern about the closing down of two prostitution website and how that will affect the District.

## Oversight Board RASA

Leslie Fritzsche said that VOA is moving forward with the Casa Grande property. She also mentioned that the City Council voted to approved the sale of the Grand Theatre to Kabul Singh.

#### **ACTION ITEMS**

### A. 5th Annual Sacramento Taco Festival Funding Request

After a lengthy discussion, the Board moved and seconded a motion to approved \$5,000 to the Sacramento Taco Festival. The vote was 8 yeses and 1 no.

He also mentioned the official closing date of the Winter Homeless Shelter on Railroad Drive and the purchase of the Rite Aid and O'Reilly building.

David gave an update on the development of businesses and property on the Boulevard, cannabis cultivation in the PBID/BIA, and an update to the temporary and permanent homeless shelter in District 2.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.
