MEETING MINUTES

CALL TO ORDER

The Del Paso Boulevard Partnership Board of Directors' Closed Session meeting for Wednesday, August 15, 2018, was called to order by the Vice Chairman, David Veden, at 8:11am.

The Partnership's regular Board session was called to order by the Chairman, Shane Curry, at 8:38AM. The meetings were held at Artspace 1616, 1616 Del Paso Boulevard, Sacramento.

ROLL CALL

Regular Session

Absent - Pat Wyluda and Laura Ham.

Staff - Executive Director, David Plag and Communications Director, Larry Groves were present.

During Roll Call, Charlie Tiwana, introduced herself and spoke a little bit about her responsibilities as Vice President of New Faze Development. Charlie will be representing Councilmember Allen Warren on the Board.

CONSENT CALENDAR

The Board moved and seconded a motion to approve the minutes for July 11, 2018. The vote was unanimous.

AGENCY UPDATE REPORT

Sacramento Police Department Update

Lt. Rudy Chan talked about National Night Out, the increase in traffic enforcement near Del Paso Boulevard and the problems with phone vendors on the Boulevard. Rudy also spoke of the problems behind El Forestro.

Paladin Private Security

Matt Carroll talked about the stats for the district, which compares the month of July 2016 to June, 2018. There was a noteworthy decrease in Alarm Activations, Fights, Intoxicated Person, Lewd Conduct, Theft, Vandalism and Welfare Checks. A marginal decease in Disturbed Person, and Unlawful Camping. There was a noteworthy increase in Narcotics activity and Suspicious Circumstances.

Overall, most stats are down. Paladin is trying to work with PD on better communication when holding a possible suspect.

Oversight Board RASA and Mitigation Fund Request

Leslie Fritzsche talked about the demolition of the Casa Grande building, the transfer of title of the Grand Theater to Kabul Singh. Leslie also asked if there is or know of anyone interested in the lot behind the Rink Studios.

Mitigation Fund Request

The City has put together an application to apply for mitigation funds for events on the Boulevard in late September and October. A total of \$20,000 will be awarded.

ACTION ITEMS

The action item on the agenda has been pulled. No action taken.

ADMINISTRATIVE REPORT

Executive Director

David gave his Executive Director's report and talked about the Grand Opening of the Grocery Outlet on September 13th, the continued work on the medical building on El

Camino Avenue, the new furniture store in the old Cooks building; Overstock Outlet US and the press for Wide Open Walls.

David gave an update on the development of businesses and property on the Boulevard, including the demolition of the Casa Grande building, the cannabis grow facilities in the PBID/BIA, and an update to the temporary homeless shelter on Railroad Avenue.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.

INFORMATION ITEMS

David talked about some of the 29 Information Items in the packets, including Wide Open Walls, the Spaghetti Feed Fundraiser at the Stoney Inn and the Taste of North Sacramento on September 8th.

COMMITTEE REPORTS

A. Treasurer's Report

David did a review of the three PBID bank accounts. The PBID has approximately \$124, 907 on hand with all bills paid.

PUBLIC COMMENTS

Pat Sayer-Handley talked about the excitement around the upcoming Taste of North Sacramento on September 8th and the support of the Partnership.

Mike Tate mentioned the difficulty in coming up with matching funds for the City's mitigation dollars that are available.

Mina Perez mention the need to change the culture in Old North Sacramento.
