### **CONSENT CALENDAR**

The Board moved and seconded a motion to approve the minutes for January 13, 2018. The motion was approved with 7 yeses and 1 abstention.

#### AGENCY UPDATE REPORT

# Sacramento Police Department Update

Sergeant Lai Lai Bui introduced herself and talked about the cannabis grow enforcement and impact teams. She also talked about the use of a bait car, and the problems behind El Forestro and the Old North Sacramento School building on Dixieanne Avenue.

## **Paladin Private Security**

Matt Carroll provided the stats for the district, which compares the month of January, 2016 to January, 2018. There has been a notable decrease in burglary and vandalism and an increase in disturbed and intoxicated persons and trespassing.

# **Oversight Board RASA**

Leslie Fritzsche said that VOA is moving forward with the Casa Grande property. She also mentioned that the City Council voted to approved the sale of the Grand Theatre to Kabul Singh.

# A. Recommendation from Marijuana Grow Facility Sub-Committee

After a brief discussion, the Board moved and seconded a motion to approved the marijuana grow facility at 2189 Acoma Street. The vote was 7 yeses to 1 abstention.

#### **B.** Selection of Executive Officers

The Board moved and seconded a motion to appoint Shane Curry as Chairman, Dave Veden as Vice Chairman, Jay Roth as Secretary and Larry Taylor as Treasurer. The vote for each was 7 yeses and 0 nos.

## ADMINISTRATIVE REPORT

#### **Executive Director**

David gave his Executive Director's report and talked about the work on the Grocery Outlet on Del Paso Boulevard and the medical facility on El Camino Avenue. He also mentioned his concerns about the Winter Homeless Shelter on Railroad Drive, the proposed permanent Homeless Shelter on Evergreen Street and the upcoming closure of Rite Aid.

David gave an update on the development of businesses and property on the Boulevard, marijuana grows in the PBID/BIA, and an update to the temporary and permanent homeless shelter in District 2.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.
