MEETING MINUTES

CALL TO ORDER

The Del Paso Boulevard Partnership Board of Directors meeting for January 13, 2018, was called to order by the Chairman Shane Curry at 9:02am. The meeting was held at the Embassy Suites, Sacramento Riverfront Promenade, 100 Capitol Mall, Sacramento.

CONSENT CALENDAR

The Board moved and seconded a motion to approve the minutes for December 13, 2017. The motion was approved with a unanimous vote.

AGENCY UPDATE REPORT

Sacramento Police Department Update

Lt. Rudy Chan introduced himself and talked about the cannabis grow enforcement and impact teams. He also talked about the hiring of new officers, how they are using the Impact Team and the uptick in nuisance crimes in the area.

Paladin Private Security

Matt Carroll provided the stats for the district, which compares the month of December, 2015 to December, 2017. There has been a notable decrease in Disturbed Persons and Prostitution, but an increase in PR visits and unlawful camping.

Officer Kish has been hired by the Sacramento Sheriff's Department, so Matt introduced Paladin's two new officers for the district, Officer Kendricks and Officer Wise.

Oversight Board RASA

Leslie Fritzsche said that VOA is still moving forward with the Casa Grande property and that Kabul Singh's offer to buy the Grand Theater goes before the City Council for a vote on February 6th.

ADMINISTRATIVE REPORT

Executive Director

David gave his Executive Director's report and talked about the opening of King Cong Brewery. He also mentioned his concerns about the Winter Homeless Shelter on Railroad Drive and the proposed permanent Homeless Shelter on Evergreen Street.

David also gave an update on the development of businesses and property on the Boulevard.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.

David mentioned the 24 Information Items on the agenda, including the Free Movie Night at Shift Coffee and the events at the Stoney Inn.

Adrian Perez mentioned the upcoming 5th Annual Taco Festival for the Boulevard.

Uptown Press Company introduced themselves and spoke about their effort to develop a print and cannabis labeling company at 1811 Del Paso Boulevard.
