## **MEETING MINUTES**

#### **CALL TO ORDER**

The Del Paso Boulevard Partnership Board of Directors meeting for Wednesday, July 11, 2018, was called to order by the Chairman, Shane Curry, at 8:42am. The meeting was held at Artspace 1616, 1616 Del Paso Boulevard, Sacramento.

#### ROLL CALL

### **CONSENT CALENDAR**

The Board moved and seconded a motion to approve the minutes for June 14, 2018. The vote was unanimous.

### AGENCY UPDATE REPORT

## Sacramento Police Department Update

Lt. Rudy Chan talked about the increase in traffic enforcement near Del Paso Boulevard and Arden Way and the That Guy Eyewear had their windows broken out. He also spoke of the problems behind El Forestro.

## **Paladin Private Security**

Matt Carroll talked about the stats for the district, which compares the month of June 2016 to June, 2018. There was a noteworthy decrease in quality of life issues; theft, welfare checks, distributed persons and lewd conduct. A marginal decease in suspicious circumstances, illegal dumping and alarm activations. There was a noteworthy increase in narcotics activity and vandalism.

Overall, most stats are down. Paladin is trying to work with PD on better communication when hold a possible suspect.

## Oversight Board RASA and Mitigation Fund Request

Leslie Fritzsche was unable to attend the meeting, but David mention that the Grand Theater was officially sold to Abdul Singh and the Casa Grande building will be demoed in late July.

# **Mitigation Fund Request**

The City is putting together the process to apply for mitigation funds and expects the applications to be out in a few weeks.

#### ADMINISTRATIVE REPORT

#### **Executive Director**

David gave his Executive Director's report and talked about the new Sushi restaurant coming to the Boulevard and the continued building of the Grocery Outlet and the medical building on El Camino Avenue.

David gave an update on the development of businesses and property on the Boulevard, including the September 13th opening of Grocery Outlet, the cannabis grow facilities in the PBID/BIA, and an update to the temporary and permanent homeless shelter in District 2.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.
