## **MEETING MINUTES**

#### **CALL TO ORDER**

The Del Paso Boulevard Partnership Board of Directors meeting for Thursday, June 14, 2018, was called to order by the Chairman Shane Curry at 8:40am. The meeting was held at Artspace 1616, 1616 Del Paso Boulevard, Sacramento.

#### ROLL CALL

**Present** – Shane Curry, Dave Veden, Jay Roth, Kevin Lutz, Deneb Williams and Mini Martinez. Daniel Savala came late.

**Absent** - Pat Wyluda, Leslie Fritzsche, Laura Ham and Larry Taylor.

**Staff -** Executive Director, David Plag and Communications Director, Larry Groves were present.

#### **PRESENTATION**

Adrian and Mina Perez talked about the success of the Taco Festival, the number of people who attended the event and how it was received with the businesses along Del Paso Boulevard. Next year's Taco Festival is set for June 1st.

#### **CONSENT CALENDAR**

The Board moved and seconded a motion to approve the minutes for May 15, 2018. The vote was unanimous.

#### AGENCY UPDATE REPORT

#### Sacramento Police Department Update

Lt. Chan talked about the cannabis grow enforcement and impact teams. He mentioned the problems behind El Forestro and the feedings by a local Church. David spoke about the help Lt. Chan has provided to the Partnership.

#### **Paladin Private Security**

Matt Carroll was not able to attend the meeting, but did provide the stats for the district, which compares the month of May 2016 to February, 2018. There was a decrease in illegal dumping, vandalism and lewd conduct, but a marginal increase in theft and suspicious circumstances.

## Oversight Board RASA and Mitigation Fund Request

Leslie Fritzsche was unable to attend the meeting, but David mention the City Council approved the request for the \$900,000 in mitigation funds for District 2.

#### **ACTION ITEMS**

#### A. Request for Funds, Crocker Art Ark

Tommy Young clarified with the Board that he was not requesting funds from the Partnership but help from the City to provide power to 1400 Del Paso Boulevard. No action was taken.

## B. Request for Funds, Walk the Boulevard

The Board discussed the "Walk the Boulevard" Second Saturday events and the request for financial support to continue the events through September. The Board moved and seconded a motion to contribute \$5,000 for invoiced expenses for future "Walk the Boulevard" events with the understanding the dollars would be reimbursed by Councilmember Warren through the mitigation funds. The vote for unanimous.

#### ADMINISTRATIVE REPORT

#### **Executive Director**

David gave his Executive Director's report and talked about the positive press on with the Taco Festival, the continued building of the Grocery Outlet and the medical building on El Camino Avenue.

David gave an update on the development of businesses and property on the Boulevard, including the new Sushi Restaurant at 1616 DPB, the September 13th opening of the Grocery Outlet, the marijuana grows in the PBID/BIA, and an update to the temporary and permanent homeless shelters in District 2.

The Executive Director also talked briefly about the proposed new Valley Rail stop in Old North Sacramento and the initiative on the November ballot that will acquire a 2/3 vote on all new taxes, including BIA fees.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.

David mentioned the 20 Information Items on the agenda, including the Live at TRS and the Summer Reception with Councilmember Warren on July 18th.
