#### **MEETING MINUTES**

#### **CALL TO ORDER**

The Del Paso Boulevard Partnership Board of Directors meeting for Wednesday, October 10, 2018, was called to order by the Chairman, Shane Curry at 8:37am. The meetings were held at Artspace1616, 1616 Del Paso Boulevard, Sacramento.

#### ROLL CALL

# **CONSENT CALENDAR**

The Board moved and seconded a motion to approve the minutes for September 12, 2018. The vote was unanimous.

#### **AGENCY UPDATE REPORT**

## Sacramento Police Department Update

Lt. Rudy Chan talked about the arson arrest that was made the prior week, the number of cars recently broken into, and the proposed fence and lighting for the El Forestro Alley. He also talked about the continued bike and motor patrols allow Del Paso Boulevard.

### **Paladin Private Security**

Corporal Burke discussed the stats for the district, which compares the month of September 2016 to September of 2018. There was a noteworthy decrease in disturbed persons, fights, theft, unlawful campaign and lewd conduct. There was a noteworthy increase in robbery and vandalism. Overall, most stats are down.

## Oversight Board RASA and Mitigation Fund Request

Leslie Fritzsche was unable to attend the meeting but David talked about the City's Sponsorship program and the upcoming Blues events, Oktoberfest and Fall Festival in October.

## **PUBLIC COMMENTS**

The Chairman asked to moved ahead to Public Comments to hear the two sides of the Measure U debate. Zack Yeates represented Yes on Measure U and Craig Powell spoke on behalf of the campaign for No on Measure U. Both sides took questions from the Board and audience.

Shane Curry addressed the Board and spoke about the recommendations by the Cannabis Sub-Committee for both projects.

#### ADMINISTRATIVE REPORT

#### **Executive Director**

David gave his Executive Director's report and talked the success of the Grocery Outlet Grand Opening, the continued work on the medical building on El Camino Avenue and the exciting ideas proposed by Capsity for the old Bank of America building.

David gave an update on the development of businesses and property on the Boulevard, including the opening of the Route 40 Auto Emporium, the Super Wash N' Dry opening on October 20, as well as the cannabis grow facilities in the PBID/BIA, and an update to the temporary homeless shelter on Railroad Avenue.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.

David talked about some of the 36 Information Items in the packet, including the Blues, Brews and BBQ events along the Boulevard and the October 27th Trick or Treat event sponsored by the Partnership.
