MEETING MINUTES

CALL TO ORDER

The Del Paso Boulevard Partnership Board of Directors meeting for Wednesday, September 12, 2018, was called to order by the Secretary, Jay Roth at 8:39am. The meetings were held at the Stoney Inn, 1320 Del Paso Boulevard, Sacramento.

ROLL CALL

Present – Jay Roth, Charlie Tiwana, Leslie Fritzsche, Kevin Lutz and Larry Taylor. Laura Ham came late.

Absent - Shane Curry, Dave Veden, Pat Wyluda, Deneb Williams and Mimi Martinez.

Staff - Executive Director, David Plag and Communications Director, Larry Groves were present.

PRESENTATION

Kabul Singh, owner of the Grand Theater, made a brief presentation about his ideals for the theater and his desire to have the community involved in the process. He has scheduled a community meeting for September 27th.

AGENCY UPDATE REPORT

Sacramento Police Department Update

Lt. Rudy Chan talked about his meeting regarding a barricade and lighting for the El Forestro Alley and the walk through with Grocery Outlet. He also talked about the continued bike patrols allow Del Paso Boulevard.

Paladin Private Security

Matt Carroll talked about the stats for the district, which compares the month of August 2016 to August of 2018. There was a noteworthy decrease in Alarm Activations, Disturbed Persons, Intoxicated Person and Quality of Life calls. A marginal decease in Fights, Narcotics activity and Suspicious Circumstances and an increase in Lewd Conduct and Robbery. Overall, most stats are down.

Daniel Savala mentioned a new ABC case against Sunland Liquor.

CONSENT CALENDAR

With the arrival of Laura Ham, the Board reached quorum, and the meeting was officially opened. The Board moved and seconded a motion to approve the minutes for August 15, 2018. The vote was unanimous.

Oversight Board RASA and Mitigation Fund Request

Leslie Fritzsche said all the applicants for the City Sponsorship program will be funded. She mentioned the Blues on the Boulevard, Oktoberfest and Fall Festival coming up in October.

ADMINISTRATIVE REPORT

Executive Director

David gave his Executive Director's report and talked about the Grand Opening of the Grocery Outlet on September 13th, the continued work on the medical building on El Camino Avenue and the sale of the Bank of America building to Capsity.

David gave an update on the development of businesses and property on the Boulevard, including the demolition of the Casa Grande building, the cannabis grow facilities in the PBID/BIA, an update to the temporary homeless shelter on Railroad Avenue. He also mentioned the death of a pedestrian on Arden Way.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.

INFORMATION ITEMS

David talked about some of the 26 Information Items in the packets, including the Grand Opening of Grocery Outlet, events at King Cong Brewery and Stoney Inn and the Reimagining Event at the Grand Theater on September 27th.

COMMITTEE REPORTS

A. Treasurer's Report

David did a review of the three PBID bank accounts. The PBID has approximately \$98,000 on hand with all bills paid.

ADJOURNMENT

With a Member having to leave, the Board voted to adjourn the meeting at 9:30am. The motion was seconded and approved with a unanimous vote.
