MEETING MINUTES

CALL TO ORDER

The Del Paso Boulevard Partnership Board of Directors meeting for Thursday, March 15, 2018, was called to order by the Chairman Shane Curry at 8:40am. The meeting was held at Artspace 1616, 1616 Del Paso Boulevard, Sacramento.

ROLL CALL

Closed Session Meeting

Staff - Executive Director, David Plag and Communications Director, Larry Groves were present.

PRESENTATION

Tommy Young updated the Board on the progress of the LaunchPad, 1414 Del Paso Boulevard and a proposed Velodrome plan adjacent to the PBID boundaries, off of Arden Way.

CONSENT CALENDAR

The Board moved and seconded a motion to approve the minutes for February 14, 2018. The motion was approved with an unanimous vote.

AGENCY UPDATE REPORT

Sacramento Police Department Update

Lt. Chan talked about the cannabis grow enforcement and impact teams. He mentioned the problems behind El Forestro and the feedings by a local Church. David spoke about the help Lt. Chan has provided with tagged cars in and around the PBID.

Paladin Private Security

Matt Carroll provided the stats for the district, which compares the month of February 2016 to February, 2018. Matt mentioned some notable incidences that Paladin Officer's were involved with, including the person who locked the News and Review's doors with a lock and chain.

Oversight Board RASA

Leslie Fritzsche said that Casa Grande property has officially been sold to VOA as of March 23. It has been requested that the City put a fence around 1340 Del Paso Boulevard.

ACTION ITEMS

A. Recommendation from Marijuana Grow Facility Sub-Committee

After a brief discussion, the Board moved and seconded a motion to approved the marijuana grow facility at 2170 Acoma Street. The vote was 7 yeses to 1 abstention.

B. Del Paso Boulevard / Arden Way Special Planning District

The Board discussed the difference type of businesses to be prohibited in the Special Planning District. With input from the audience, the Board determined the marketplace would sort out certain businesses but did require a CUP for tobacco retailers. The Board moved and seconded a motion to prohibit used tire storage and sales in the SPD and require a CUP for new tobacco retailers. The vote for unanimous.

ADMINISTRATIVE REPORT

Executive Director

David gave his Executive Director's report and talked about the press event for the Grocery Outlet on Del Paso Boulevard and the proposed \$80 million Harvard Development Project on Arden Way.

David gave an update on the development of businesses and property on the Boulevard, marijuana grows in the PBID/BIA, and an update to the temporary and permanent homeless shelters in District 2.

The Board moved and seconded the Executive Director's report. The motion was approved with an unanimous vote.

David talked about the Information Items on the agenda, including the Never Board Graphics' Second Saturday events and the King Kong breweries' Art Party Night.
