The districts were heavy with activity. Although no unwanted activity or security issues were seen during the initial inspection of all other boundaries and zones of the district.

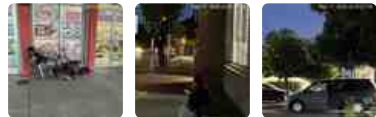
