The districts were heavy with activity. Although no unwanted activity or security issues were seen during the initial inspection of all other boundaries and zones of the district.

### Transient Activity

FTO Schroeder resumed patrol of the district patrolling through Zones 1 and 4.

During the hourly inspection of the zones we found the following issues:

- O'Reilly's: I contacted multiple transient subjects loitering in the rear of the business at the Loading Dock. All subjects were advised to leave and were compliant.

-1914 Del Paso Blvd: I contacted two female transient subjects that had been sitting on the sidewalk for some time. Upon contacting them, one female was upset and advised that she was visiting her family tree. The female also reported that someone had vandalized the tree many nights prior. They were advised to move along and not settle within the boundaries of the Del Paso Partnership.

Lt Smith and FTO Schroeder resumed patrol of the district patrolling through Zones 4-8 During the hourly inspection of the zones we found the following issues:

- -2213 Del Paso Blvd: Contacted a black male adult transient subject seated in front of the business (see photo). As soon as he observed our presence, he began to pack up his belongings. The subject left the property without incident.
- -Sacramento Youth Center: Contacted a white female transient subject sleeping in front of the building. After several advisements to depart, the female refused to leave. I proceeded to contact the Sacramento Police Department and requested assistance in removing the subject and issuing a notice of trespass. While awaiting the arrival of Sacramento PD, the subject packed up her belongings and left the property. I proceeded to call back and cancel the response of the officer.
- -1001 Del Paso Blvd: I observed graffiti on the front of the building (see photo).

- -Grocery Outlet: I observed a white Honda Accord (CA LP# 6ZPX320) parked in a handicap space in the parking lot. I proceeded to contact the occupant, a white female adult, and inquired as to why she was in the parking lot of a closed business. She stated she was waiting for a friend and I advised her to wait else where. She was compliant and left the property without incident.

FTO Schroeder resumed patrol of the district patrolling through Zones 1, 4, 6, and 7.

During the hourly inspection of the zones I found the following issues:

- 1215 Del Paso Blvd: While on routine patrol, I was flagged down by a 62 y/o white male adult in front of the business. Upon contacting the subject, he stated he had congestive heart failure and was complaining of chest pain in addition to shortness of breath. He then requested medical assistance. I proceeded to notify emergency services. A short time later, Engine 20 and Medic 20 from the Sacramento Fire Department arrived and began to render aid. The subject, identified as Larry, was ultimately transported to Kaiser South for further evaluation.
- 2422 Del Paso Blvd (Metro PCS): Contacted 4 subjects, 2 black male adults and 2 black female adults, loitering in front of the store (see photo). They were advised to leave the property and were compliant.
- 2125 Del Paso Blvd: Contacted 3 transient subjects; a while male adult, a black male adult, and a black female adult, after I observed them loitering on the side of the business. I advised them to depart and they were compliant and left without incident.

During the hourly inspection of the zones I found the following issues:

- 840 El Camino Ave (Dollar Tree): Contacted a black female adult transient subject who was sleeping at the entry doors to the business (see photo). Upon contacting her, she was immediately argumentative and continuously interrupted me every time I attempted to advise her to leave. After she had finally allowed me to advise her, she was compliant and left then property without incident.
- 1716 Del Paso Blvd (Lil Joe's): Contacted a white female adult transient subject who was loitering in front of the business. I advised her several times to depart from the property. She repeatedly requested I contact "the real police" to advise her to leave. I proceeded to contact the Sacramento Police Department. While awaiting the arrival of the Sacramento Police Department, the female subject poured the remainder of a can of Mikes Hard Lemonade into a black metal water bottle and began to consume the alcohol. At approximately 0348 hours, 3 units from the Sacramento Police Department arrived and contacted the female subject. I advised them of the alcohol possession and consumption. They advised her to dump the alcohol out and she was compliant. She was identified as Krista Deluca and was advised to leave the property. She was compliant and left without incident. No trespass notice issued at this time.

During the hourly inspection of the zones I found the following issues:

- 2517 Del Paso Blvd (McDonald's): I observed a grey Toyota Sienna (CA LP# 6WUL699) parked in the rear of the parking lot of the business. I proceeded to contact the occupant, a black male adult, and advised him to leave the property. He was compliant and left without incident.

- 2419 Del Paso Blvd (Overstock Outlet US): Contacted a black female adult transient subject that was loitering in front of the business. I contacted her previously at the Dollar Tree. I advised her to leave and she was once again argumentative but compliant. She proceeded to leave the property without incident.
- 2109 Del Paso Blvd (N. Sac Hagginwood Library): Contacted two transient subjects, a black male adult and a white female adult m, who were loitering at the doorway to the Library. I advised them to leave the property and where to relocate. They were compliant and left without incident.
