It seems to me that there is no "vote" whatsoever involved in the garbage dilemma- only to opt in or out of the garbage clean up and drag to the street duty.

I think the option of individual garbage cans for each unit kept in each units garage area should be an option on the vote and there is no reason for it not to be to see how how all unit owners feel about it.

I personally don't think its right that one person/one unit should be responsible for everyone's garbage, even if it is for one month only. What is the recourse if someone assigned for the month doesn't complete the task or does a crappy job? That should also be addressed up front. How will who gets what month be selected?

Rotating garbage detail duty was voted a big NO at the 2019 annual meeting.

The Spectrum document is not clear to me unless the new contract does not need to be all units included. Not sure if voting to keep current contract until April 2023 (2 years from now) and renegotiate prior to that contract end date, why the person voting for that would have to pay \$75.00/month out of their pocket until April 2023 when it is a bill currently paid by the HOA.

Thank you for your feedback.

- 1. At the current time only 3-4 people are taking care of trash duties for all 12 units and that also is not fair.
- 2. If someone misses thier turn during thier designated month and does not get someone to cover it in advance, then they will be charged the \$60.00 yearly fee for that year since they did not complete their month.
- 3. If they are doing a crappy job. I or another board member will personally let them know and show them what is expected to complete the job correctly.
- 4. Thank You for the typo correction. I will update it asap and before anything is posted or forwarded to the owners.
- 5. Months will be chosen first according to our elderly or disabled since they will have volunteers taking care of thier trash duty. And since these owners are volunteering for extra trash duties, they will be allowed to choose thier designated month first. Then we will gather everyone's request for a designated month and see if there is any conflict. If there is not, great. If there is conflict, we will settle it with yearly alternations, or another way purposed by the board.

Vote Option #1 clearly states that you agree to pay an additional year once the cable is off and the contract is ended in order to fill a year of HOA reserves. This is a compromise because. If everyone voted to NOT sign a new contract then the HOA would no longer be charged by Spectrum so in theory, we would not be charging the portion of the spectrum bill to our owners any longer. But technically this is a service that been brought in by previous boards and would not require the board to lower the already in place HOA dues. So technically the cable contract could run out, but the dues would remain the same until that issue was brought up and voted on with reserves in mind. So I have proposed the one year of not lowering the current HOA due to help fill reserves if this option is chosen. Eventually reserves will become an issue with all the upcoming maintenance I foresee over the next 5-10 years, so I am proposing ways to alleviate this as early as possible. I am sorry you feel like this is a punishment if one were to choose this option, but I assure you it is not and will always serve the owners best interest whether it be immediately, overtime, in the long run, and most definitely in the event of a catastrophe.

I think the HOA dues should stay the same regardless of how the Spectrum vote goes. With the exception of when they were raised due to a delinquent owner, they have not increased in quite a while and we need to keep our reserve funds up.

I would think the Spectrum voting options should be:

1. Re-sign now which locks us in for 5 years

Or

2. Letting our current contract run out which will happen in 2 years and at that time check rates to renegotiate and vote at that time if we want to be locked in to another lenghthy contract,, or vote to have all unit owners get their own cable/internet individually.

To me what was proposed did not represent those 2 choices clearly.

I was by no means saying that you personally were trying to strong arm anyone - its just to me, when I read the choices to vote on, it doesn't seem clear that we have the option to ride out the contract until it ends in 2 years, and then decide, and I still don't think that 75.00 would need to be individually collected or refunded.

My trash can is in my garage and I don't think that a few miles down the road the temperature inside my garage is any cooler than yours. Plus, the trash gets collected 2 times

per week, so trash is not stagnating for any length of time. I think it would be common FL resident sense to maybe keep meat/chicken scraps, etc. in your freezer until trash day - that is what I do and most people do to avoid the situation you described.

Probably now most don't do that because it is a public free for all with no accountability in the current trash area.

That is probably a big part of the issue we currently have. They would probably not be such a non-caring slob if they were accountable to clean up or avoid their own mess with their own trash can.

Why not put my original proposal on the ballot since we only know your feelings on this PLUS the proposal that the 4 private garages be responsible for their own trash/recyclables and the shared garages can do the trash rotation duty.

The point is. We are already collecting dues for a Spectrum service this is currently being provided. If we no longer provide that service and are not being charged by Spectrum for that service, then the HOA is building reserves at a rate of 10k a year forever just from the old Spectrum dues and I am all for that. Then the question of how much in reserves are needed? 10 years with just the old Spectrum dues is 100K in reserves of money sitting and not fully working

for us. The option to only pay 1 additional year for the service that was removed was just a thought to be courteous to owners and pad the reserves a little with this opportunity to do so. So, the point is to try and meet the needs of the Owners needs and the HOA needs without impacting dramatically.

On your option for the Trash opt out to be put on the ballot. I cannot go any further until we have Tony and Darryls input, unless it is worded to accurately detail exactly what it entails. I see the 2 car garages being able to have a special option, but still need clarity on what happens to the shared owners trash duties. Take some time and think about it, we will get there. There are always "what ifs" and on this proposal I see a lot of them, and almost certain Darryl and Tony would as well. I have attached pics of the 203 shared garages. I am commenting only on the trash issue at this time. I will address each issue prior to the deadline of the 28th, but I understand that you are waiting on Tony and my input on the trash. I agree and was under the impression that we had already voted, at our first meeting, that we would NOT do trash in owners garages. I think that even presenting the issue of trash cans in the garages, to the owners to vote on, would be an absolutely ignorant proposal coming from the PepperTree Board. I am in agreement 100%, that placing 8 trash cans in the center garages would become a crisis! You have addressed the issue with storage space perfectly and it should not be forwarded to a vote for owners, as the current issues with the trash area can be addressed with adequate rules as you have proposed.

The only comment I have on the Trash System Proposal is that the "Opt out" price of \$5 per month is too LOW. The rat situation that Darryl was referring to was due to a unit owner passing, and the unit was vacant for a very long time and Peppertree did not have unit access to do the routine attic exterminator services This was the same unit that stopped paying their HOA dues.

HOA dues had to be increased to make up for the delinquent owner dues and Peppertree only recapped a miniscule amount when the unit finally sold.

I don't know all of the Peppertree residents well but do not forsee the end unit single garage residents creating an unsanitary garbage situation in their individually owned garages.

I think the new Spectrum contract is a much better deal than what we had and will benefit those resident owners.

It is a big plus that the rate is lower and that dues will not have to be increased.

I will draft a proposal for the end units being responsible for their own trash and storing cans in their own garage.

I am ok with the higher opt out fee.

As far as the reserves, we have never really had a huge balance with the current monthly HOA dues amount

as there was always some situation (hurricane damage, etc.that required funds).

Not to be pessimistic but I don't think that the gutter install alone will solve the uneven asphalt flooding situation, but we can always mandate an assessment if funds are low for the plan B (drain) solution.

This proposal would give owners with individual garages only the option to be responsible for their own trash removal and cans. This would involve purchasing their own personal trash can to be stored in their unit's individual garage, and taking their can to the street on trash days, and bringing it back to be stored in their garage in a timely manner.

Any garbage in their individual can would need to be brought to the curb on collection days and not stored in their garage. The public area trash cans would no longer be available for them to use.

Participation in this proposal would also include discarding and maintaining recyclables in the same manner.

This would eliminate the forthcoming mandatory participation or monthly \$15.00/yearly \$180.00 opt out charge of each individual unit to be responsible for a 30 day consecutive period of bringing all common use trash and recyclable cans to and from the street on collection days and hosing out cans and keeping the garbage can collection area clean and insect free for their assigned month(s). Individual garage owners participating in this proposal would lighten the load of the public access cans to be moved and maintained.

This proposal would give individual garage unit owners the choice on how they would like to have their trash removed.

Any individual garage unit owner can also choose to participate in the community trash rotation schedule or opt out fee program instead of maintaining and storing their own trash can.

Thank you for your submission of your proposed trash solution. I would like to see something in this that addresses full responsibility of charges for any damages or sicknesses if a rodent problem becomes directly linked to keeping trash in these oversized unventilated garages. I would also like the word mandatory removed and changed to "upcoming vote" or something to that nature. I agreed at the last meeting that instead of making a 3-1 decision on a trash solution at that time. We would take your request into consideration and ask the owners for a vote on options which nullifies anything "mandatory" being imposed on owners without their signed vote. We are now working on this. As it is written right now my position to submit this new proposal of yours to owners would be No. There are 10 owners this would not apply to. You still have until 4/28/30 to create a proposal and submit it to the other 3 board members. As it stands at this point the count is an unofficial 3 to 1 against.

The upcoming votes are majority rule, and a tie would go to the HOA Board member vote results. Since there are 4 2 Car garage owners and 2 of them for certain do not want trash cans in their garages for their own reasons. The best result this option could garner is a 2 to 2 vote sending it to the Board which at this time is at 3 to 1 against it.

It may be possible the 3rd voting option would read like this.

And in that outline of those duties there is no where that states that your personal agendas try to become accomplished by the position you were voted to handle. Nor does it say in those duties to undermine the boards positions and duties by creating more situations to discuss and debate over than necessary. In this situation from the beginning you have sought to figure out an option that appears to mainly serve your own best interest rather than all 12 owners equally. We have a democracy and a system in place. In the future this will be strictly adhered to. If you have a proposal that has the overall best interest for all owners covered fairly and equally, we will be more than happy to give our full attention to that proposal. But if in the future they are not, we will not be able to spend the amount of time that we are spending on this issue and in the future those ideas or proposals will be immediately dismissed especially if they are not solving the problems as equally as possible for all 12 owners. We are all here in the best interest of all 12 owners regardless of thier daily status at the property and need to do our very best to act in the best interest of ALL 12 owners and not any less than that. We will do our best to create a blanket set of options that solve the issues, and is as fair and equal as possible for our 12 owners. I ask as favor from everyone to try and leave the past in the past and take the important lessons and knowledge gained from it forward. Put any differences aside as difficult as that may be and lets take our positions and do a good job of them and makes this property and board a well oiled machine and as a reward a cakewalk for all of us.
