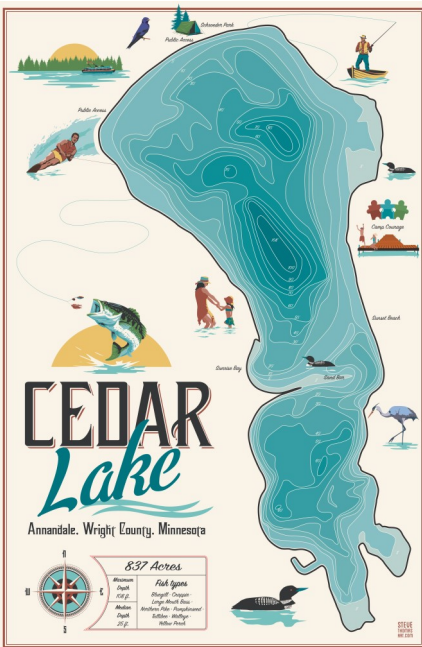

This is my first letter as President of the Cedar Lake Conservation Club. I am happy to serve this organization and consider it an honor to help lead a volunteer group that has a respected reputation and over half a century of focused lake stewardship. My family has been coming up here since 1964. We are seasonal residents of the lake. We have experienced droughts, high waters, no-wake zones, thick weeds, excellent water clarity, and poor water clarity. This organization has done a tremendous amount of work to clean the lake and rid it of invasive weeds so we can enjoy the lake we have today. We all need to be aware of how we use this resource, so we can leave it better than we found it.

We have seen tubing evolve from a 3 horse Johnson on a 10-foot boat using a hemp rope pulling a tractor innertube, to tri-hull pontoons pulling water skiers. That still looks odd to me, as our first pontoon occupancy was limited to the number of lawn chairs you brought on board. We have had experience pulling in docks in heat, wind, rain and snow. The crazy badges of honor for lake life.

Our summer was hot, dry and we had that unwelcome filamentous alga, caused by the heat and drought, changing the way we used the lake this past summer. Let's all hope for normal weather to return. We had great water clarity this year, and it seems more zebra mussels on our lake equipment.

The CLCC Member Annual Meeting was held September 25 at Corinna Township Hall. Our guest speaker, Jeff Forester from MN Lakes and Rivers (MLR), spoke on aquatic invasive species control efforts with watercraft cleaning, such as we provide with our CD3 station at Schroeder and staffed monitoring at landings. He highlighted work MLR has done with beef ranchers to improve soil resiliency and improve the downstream water quality.

Finally he reviewed a new MLR initiative—the Lake Steward Program—to support lake associations to encourage lake scaping stewardship. This involves steps such as native plantings and shorelines, water runoff mitigation, and well maintained septic systems. Check out their website [mnlakesandrivers.org](http://mnlakesandrivers.org). 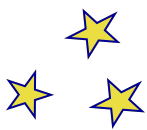

# CLCC Member Annual Meeting Recap

CLCC held the Annual Member Meeting on September 25th at Corinna Township Hall. Attendance was good and the highlight was guest speaker Jeff Forester of Minnesota Lakes and Rivers (MLR).



MLR is an advocacy group solely focused on protecting Minnesota's lake and river heritage for current and future generations by forging powerful links between lakes, lake advocates and policy makers.

His presentation was heart felt and authentic with the umbrella theme of lake stewardship. MLR projects reviewed were:

- **Stop Starry** | MLR secured legislative funding to put CD3 boat cleaning stations at Minnesota lakes infested with starry stonewort.

- **Up the Creek Meats** | This partnership with a rancher focuses on land stewardship to improve water quality.
- **Lake Steward Program** | Support for lake associations to encourage mindful shoreline landscaping.



Other items at the Member Annual Meeting include:

- Announcing fishing contest winners (see page 9).
- Electing Officers and four new Directors (see page 4).
- Recognizing out going directors: Renee Bianchi, Mike Cole, and Jim Kuhn. Each served a four year term on the Board.

### Ice Fishing on Cedar

With the increased clarity of the water on Cedar Lake, it will be interesting to see how it affects the winter fishing season. Cedar has always been a late day, night, and early morning bite for those elusive walleyes during this time of the year. That probably won't change, but for the other species we will see.

For those that use a spear to go after northern pike, the increased clarity will be welcome. Expect to see additional dark houses (spear fishing houses) on the ice this winter season, especially as the water gets even clearer because of the discovery of zebra mussels in 2018.

Over the years, the spearers have been great, for the safety of others, to mark their large hole with a branch after they leave. We thank you!

As a reminder please pick up anything that you may have left around your ice fishing area. Have fun and enjoy the winter fishing season!

Be safe out there and please be careful as you venture out on the lake, especially during early ice.

### DNR Stocks Walleyes in Cedar this Fall

In late October, the DNR stocked 401 pounds of fish, which equated to 4,826 of walleye fingerlings and adult fish in Cedar Lake. According to Joe Stewig, DNR Fisheries Manager, it was a tough harvest this fall. They were unable to get into some of their rearing ponds because of low water; additionally, there was a lack of fish.

The great news is that we were one of the lucky lakes and got our quota! Working with the DNR and your sustained support of our CLCC Walleye Visionary Fund, we will continue to keep Cedar Lake one of the greatest fisheries in the area. Our next CLCC walleye stocking is set for the Fall of 2022. As of this writing, there is almost \$3,000 in the fund for the 2022 stocking. 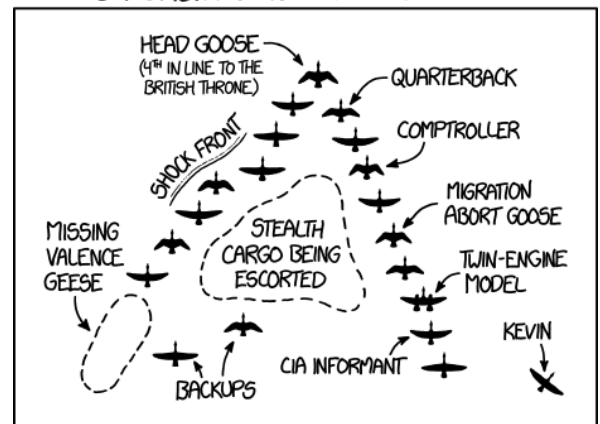
### Paul's Corner | The Fall Migration

Many of the species of birds we see around Cedar have headed south for the winter. But for our loons, they can be the last ones to leave just before ice up. The loon's chicks born this summer were the first loons to leave; they will head to the Gulf of Mexico and reside there for one to two years before returning.

Cedar, which is one of the last lakes to freeze in the area, usually hosts plenty of waterfowl in the late season. Enjoy the rhythm and show of the migration.

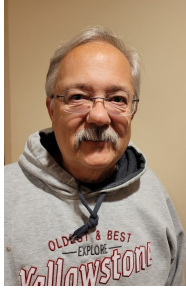
As for those lucky enough to live on Cedar full time, keep those bird feeders full and enjoy nature at its best through your window this winter. Every season brings a dazzling show!

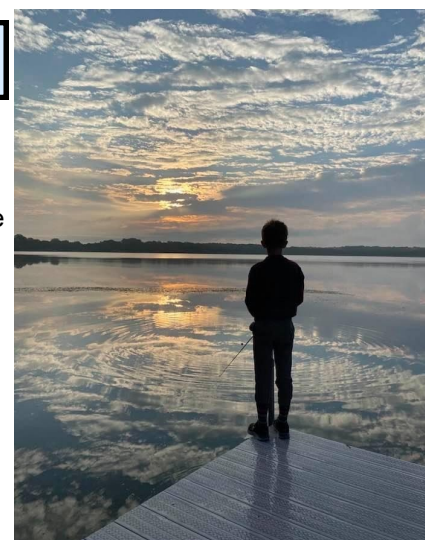

# What's in Our Water?

## Proper Disposal of Unwanted Medications

### What's in our water?

- Pharmaceuticals
- Fragrances
- Fire retardants
- Detergents
- Insecticides



Research by the Minnesota Pollution Control Agency (<https://tinyurl.com/ebc3js42>) confirms a wide range of unregulated chemicals is ending up in Minnesota's lakes and rivers.



### 2017 Study | Pharmaceuticals and Chemicals of Concern in MN

50 lakes, selected at random, sampled for 163 chemicals.

- Of the 163 chemicals, 55 were found in the lakes at least once.
- **All 50 lakes contained at least one contaminant.**

The chemicals, including pharmaceuticals and personal care products, are of concern because many have properties that can interfere with the functioning of hormones in animals and people.

### Where are the chemicals from?

Sources of these chemicals to surface water include municipal wastewater discharges, septic systems, runoff from animal agriculture, storm water, and even rain and snow.

### How do I dispose of unwanted medications?

**Don't flush old or unwanted prescriptions or over-the-counter medications down the toilet or drain and don't put them in the trash. Dispose of unwanted medications for free at licensed location disposal sites.**

- Most collection bins are located indoors and accessible during normal business hours.
- Keep in original containers; remove patient information and prescription numbers.

## Limited AIS Treatment Needed in 2021 | \$4,000 in Grants Received

The Water Quality Committee is delighted to report that, again this year, limited aquatic invasive species (AIS) control was required on Cedar.

The only AIS requiring treatment was curly leaf pondweed, with 4 acres treated in May.

We anticipated there would be limited eurasian water milfoil to treat this year. After two inspections to identify the amount of EWM to treat, our vendors reported that there were no patches of EWM requiring treatment. However, there is a patch of potentially hybrid-EWM (cross between native and invasive) and further analysis and inspections are planned for early 2022.

And once again, **none of the newest invader—starry stonewort—was found on Cedar.**

Below is a summary of the AIS financials. \$4,000 in grants were secured from government agencies to help with the costs.

The Water Quality Committee remains vigilant and is already making 2022 plans for AIS control. The Committee will continue to work with the DNR and a variety of other lake management experts to develop thoughtful, comprehensive and cost effective AIS management strategy.

## CLCC Extra Access Monitoring Over 1300 Inspections in 2021

CLCC made another major commitment this year to reduce the spread of aquatic invasive species (AIS). As in past years, Wright Soil and Water Conservation District provided a program for lakes to purchase additional access monitoring to augment the access monitoring provided by Wright County.

The CLCC Board of Directors contracted for an extra \$32,000 of access monitoring in 2021, but due to staff shortages, ended up spending \$26,200.

Here is a summary of the 2021 Cedar access monitoring statistics:

- 1,313 inspections.
- 1,651 hours of inspections for a total cost (includes inspections provided by Wright County) of \$32,600.
- Inspections per hour were 0.91, which is a decrease from record year 2020, but like other years.
- Fishing boats were the most common watercraft inspected.
- 101 entrance inspection violations were detected, up from previous years.

## 2022 Aquatic Invasive Species Treatment Waiver

Cedar Lake Property Owners:

The Cedar Lake Conservation Club (CLCC) plans to treat curly leaf pondweed and eurasian water milfoil, both aquatic invasive species/nuisance species, in Cedar Lake in 2022. Additionally, if starry stonewort, an aquatic invasive species, is discovered, treatment will be conducted.

The Minnesota Department of Natural Resources is planning to provide to the CLCC a waiver of the requirements that the Association obtain signatures of approval by owners of lakeshore property. Instead, the CLCC will notify property owners of the treatment through the:

- CLCC newsletter which is mailed to all residents of Cedar Lake.
- CLCC website [www.cedarlakecc.org](http://www.cedarlakecc.org)
- Annandale Advocate and Maple Lake Messenger (local weekly newspapers).

With regard for 2022 treatment:

- The proposed timeline for treatment is May – October.
- The target species for the treatment is curly leaf pondweed (CLP), eurasian water milfoil (EWM), and starry stonewort (SSW) if discovered.
- The products being used are aquatic herbicides and/or harvesting methods appropriate to control CLP and EWM, and SSW if discovered. Chemicals that are anticipated to be used are: CLP-diquat, EWM-ProcellaCOR, SSW (if discovered)-copper sulfate.
- **If landowner does NOT want treatment to occur adjacent to the landowner's property:**

## Cedar 2021 Zebra Mussel Resident Survey Most Report More

Thanks to all who completed the zebra mussel survey that was sent out in September. Zebra mussels were discovered at multiple locations on the lake in 2018. Zebra mussels disrupt the ecological food chain and the long-term impact to lakes is difficult to predict. Given the lake wide infestation, with current chemical treatment strategies, we are not a candidate for treatment.

Results are still coming in from the survey, however here are a few preliminary trends:

- 99% of the residents saw zebra mussels on their equipment.
- 71% saw a heavier presence on their equipment compared to 2020.
- 77% described a moderate to heavy presence on the equipment.

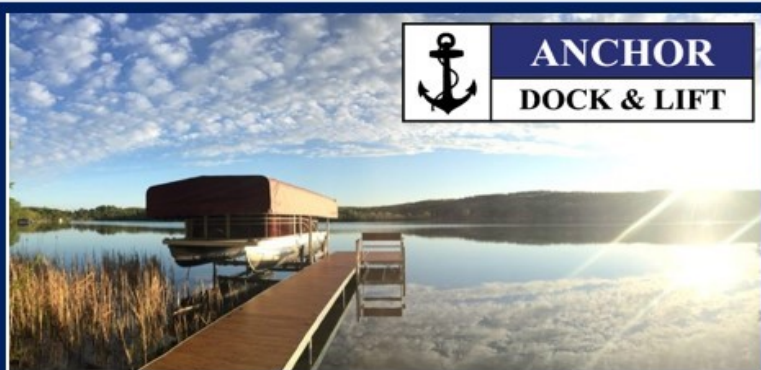

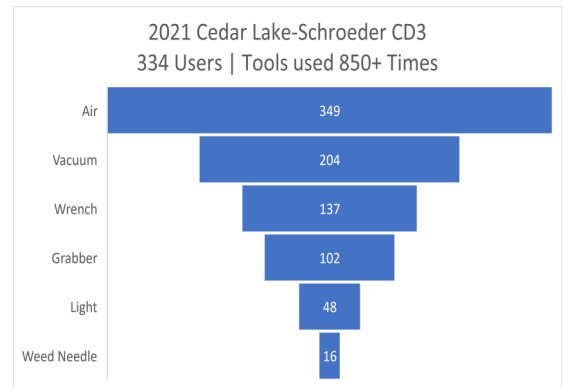
## Watercraft Cleaning Station at Schroeder Park Spectacular 2nd Year With Tools Used 850+ Times

The cost is \$24.95, and must be 12 years old to take the test.

**Q: Do you need Minnesota Boating Education?**

**A:** You need education if you are 12-17 years old, unsupervised, and will be operating a boat over 25hp. And yes, if you are 14 to 17 years old, are unsupervised, and will be



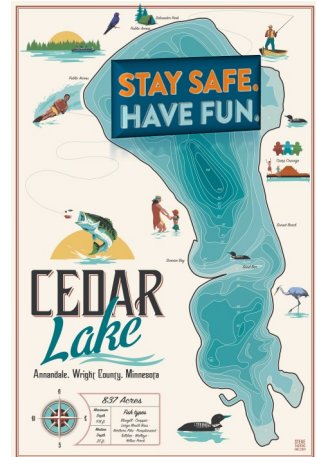

- Sweatshirts were sold as a fundraiser for \$5 each.
- The public hearings for the formation of the Clearwater River Watershed District were started.
- 8.8 acres of land near Cedar Lake was advertised for \$1,500 per acre.

- Fund raisers were held to help build a new medical clinic in Annandale.
- Bullhead harvesting continued with another 1,300 pounds removed from Cedar Lake.
- Planning for the first ever Cedar Lake Directory was started, with the first directory distributed in the summer of 1974.

## Cedar Lake Favorite Recipes By Karen Lohn



This is a wonderful fall recipe that is a sure winner from my mother-in-law—Grandma Lohn. Autumn vegetables, savory chicken, which easily doubles for lake company. Enjoy!—Karen Lohn

### Grandma Lohn's Chicken Ratatouille

1/4 cup olive oil  
2-3 chicken breasts, cut into 1" pieces

- 2 small zucchini, unpeeled, cut into 1" cubes
- 1 eggplant, peeled, cut into 1" cubes
- 1 large onion, thinly sliced
- 1-2 medium green peppers, cut into 1" cubes
- 1/2 pound mushrooms, sliced
- 1 lb tomato wedges
- 2 tsp garlic salt
- 1-2 tsp dried basil (I use a ton of fresh basil)
- 1-2 tsp dried parsley (I use fresh, chopped parsley)
- 1/2 tsp black pepper

Heat olive oil in large pan. Sauté chicken on each side about 2 minutes. Add zucchini, eggplant, onion, green pepper, and mushrooms. Stir over medium heat for about 15 minutes, or until tender but still crisp. Add tomato wedges, then herbs and spices. Simmer about 5 minutes. Serve on cooked rice of any kind.


