This month's issue of the Cedar Lake News is being mailed to our readers along with a brochure which has been put out by the Clearwater River watershed District Foundation, Inc., a non-profit organization formed recently to undertake the establishment of a watershed district in our area

The purpose of such a district is to create a local unit of government which has the necessary jurisdiction and authority to handle the increasing problems of pollution in our areas lakes and streams.

Many of you, especial ly if you are residents of the Minneapolis and suburban areas, are perhaps familiar with water shed districts already. In essence, what a watershed district is is a unit of government, with varying degrees of size, shape and location, which is directly concerned with the management of all the water resources of a given area and its drainage patterns. This district in turn produces rules, regulations and projects that will improve the waters of that district.


Talk of forming such a district for our area has been bandied about for some time, but now concrete measures have already been taken by a number of individuals from neighboring Clearwater lake. In fact, most of the time consuming meetings, conferences

and structural planning sessions have been accomplished. And hopefully, within a year's time, this district will be a reality.

The accompanying brochure, which we urge all of our members and lake shore owners to read, explains in more detail just what this district is and what it can do for us. As the map on page one of the brochure shows, Cedar Lake will fall into such a watershed district as is proposed. Our lake is topographically situated within the natural drainage basin of the Clearwater River System. It is hoped that at our spring meeting the executive director of the Clearwater River Watershed District Foundation can be present to answer questions you may have concerning this project.

#### ICE-OUT

The ice on Cedar took considerably longer in making its exit this year as opposed to last. Ice-out on Cedar this year took place sometime between late Thursday night, April 18, and early Saturday morning, April 20. Strong southerly winds completed the work swiftly once warm temperatures thawed the ice from around the lake's shoreline. Last year, however, Cedar was free from ice around the first of April.



## FGR. INC. SERVED. WITH SUMMONS

On Monday, April 15, Wright County Sheriff Darrell Wolff served on Mr. Daryl Gunnarson a summons and complaint in the case State of Minnesota by Cedar Lake Conservation Club et al., v. FGR, Inc. of Annandale.

According to the law, the defendants, (FGR Inc. are required to serve an Answer to the Complaint to our attorney, Mr. Hartfeldt, within 20 days exclusive of the date of service. If requested by the defendant, a maximum of an additional 20 days can be granted.

If, after that period of time the defendant still has not answered the complaint, judgement by default will be taken against the defendant for the relief demanded in the complaint.

As of May 1, our attorney has not received an Answer to the Complaint. More detailed information on this legal action taken by our club will be presented at the spring meeting in Annandale on May 26. We will welcome any and all questions from our membership at that time.

### LOOK'S CORNER

With spring now rushing in some long awaited warmer weather, it won't be long before some of of our first garden crops become ready for the table. One of our neighbors has already reported that his green onions are ready for picking and eating. And I'm sure that that early vegetable (fruit?) rhubarb will be ripe for harvesting pretty soon. This issue's recipe is for a delicious dessert that makes good use of our early friend rhubarb. (Doesn't your mouth already water with just the mention of that word?) This recipe is submitted by Mrs. Ron Dircks.

#### RHUBARB CRUNCH

1 cup flour
5 Tbsp. powdered sugar
1½ cups sugar
3/4 tsp. baking powder
2 cups cut-up rhubarb

 $\frac{1}{2}$  cup buttaer 2 eggs  $\frac{1}{4}$  cup flour salt to taste

Mix together flour, powdered sugar, and butter. Pat into 9 inch pan. Bake 350 degrees for 15 minutes. Beat eggs until fluffy and gradually add sugar, flour, baking powder and salt which have been sifted. Add rhubarb and pour over crust. Bake for 35 minutes.
