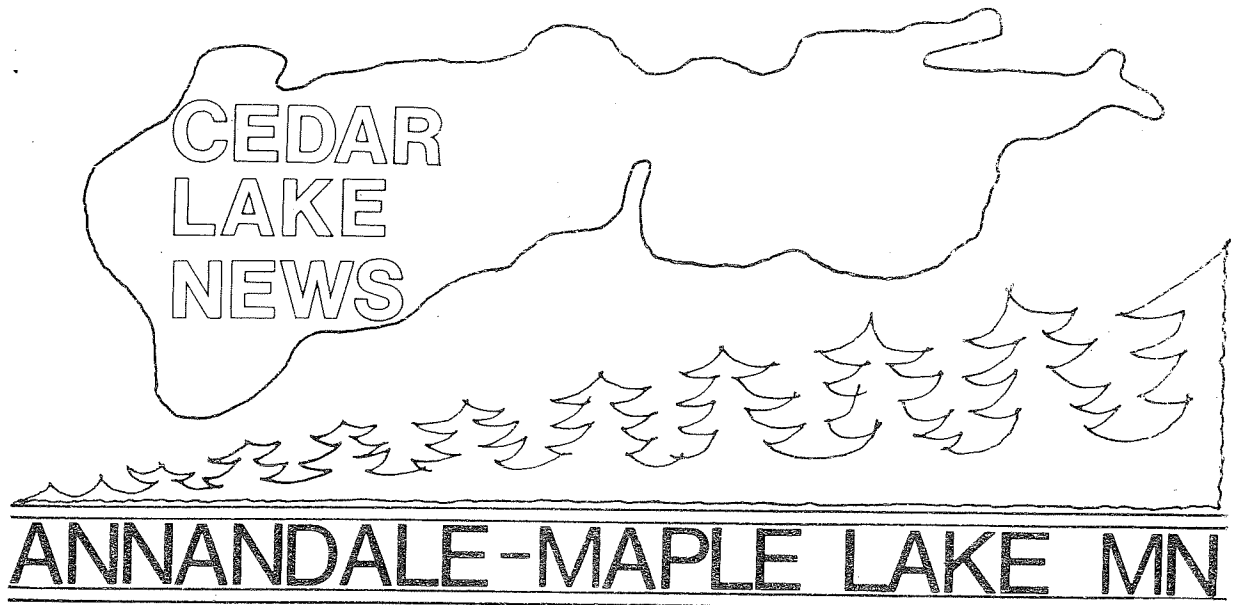

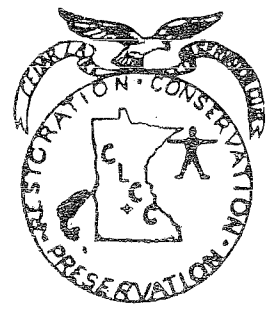

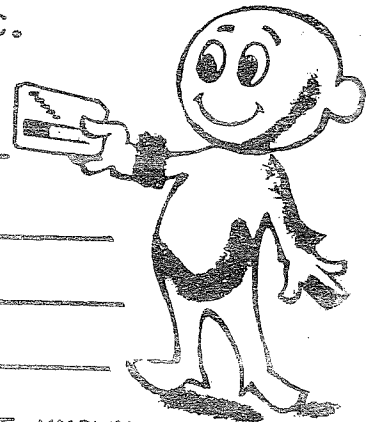

HIGHLIGHTS OF C.L.C.C. BOARD MEETING OCTOBER 16, 1976 AT  
THE TOWN CLUB, ANNANDALE, MINNESOTA

WITH THE RESIGNATION OF OUR PRESIDENT, JUDITH DRAPER, OUR VICE PRESIDENT, ROGER NORDBYE ACCEPTED THE OFFICE OF PRESIDENT FOR THE REMAINDER OF THE TERM WHICH EXPIRES AUGUST 1, 1977. THE NOMINATION COMMITTEE WILL SEEK CANDIDATES FOR THIS OFFICE AS WELL AS OTHER OFFICES THAT WILL EXPIRE AT THAT TIME.

SHORT DISCUSSIONS WERE HELD ON THE FOLLOWING SUBJECTS:

1. TYPE OF MEETINGS (SOCIAL OR NON-SOCIAL) AND HOW MANY PER YEAR.
2. CREEK AT SOUTH END OF LAKE (MEMBERS WERE GOING TO VISIT CREEK AFTER MEETING)
3. HENNEPIN COUNTY PARK PROPERTY LOCATED ON THE NORTH END OF CEDAR LAKE. ELLA GEARDINK WILL KEEP IN TOUCH WITH WRIGHT COUNTY COMMISSIONERS AND INFORM THE CLUB OF ANY ACTION TAKEN BY EITHER COUNTY.
4. TREASURER REPORT WAS GIVEN AND REPORTED THAT CHECKS FOR THE 1976 FISHING CONTEST WINNERS HAD BEEN MAILED OUT. CORRESPONDENCE RECEIVED WAS SHOWN TO THE BOARD.
5. VOTED NOT TO RAISE DUES FOR 1977 AND CONTINUE TRYING TO COLLECT 1976 DUES.
6. BOARD APPROVED HAVING A FISHING CONTEST FOR THE 1977 SEASON. DETAILS WILL BE FORTHCOMING IN A LATER ISSUE.

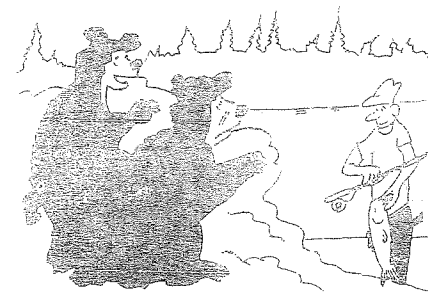
HUNTING, FISHING LICENSES

PERSONS WHO HUNT AND FISH IN MINNESOTA WERE REMINDED THAT THEIR LICENSES ARE GOOD UNTIL MARCH 1, 1977.

ROBERT WELLS, CHIEF OF THE LICENSE CENTER FOR THE DEPARTMENT OF NATURAL RESOURCES, SAID THAT THE LICENSES DO NOT EXPIRE AT THE END OF THE YEAR ON DEC. 31 AS THEY DID PREVIOUSLY.

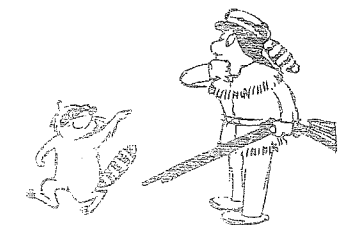
"THE LAW WAS CHANGED AT THE DEPARTMENT'S REQUEST BY THE LAST LEGISLATURE," SAID WELLS, "SO SPORTSMEN COULD USE THEIR LICENSES THROUGH THE CLOSE OF THE SMALL GAME SEASONS AND MOST OF THE ICE FISHING SEASON."

IS IT AN AQUATIC NUISANCE?

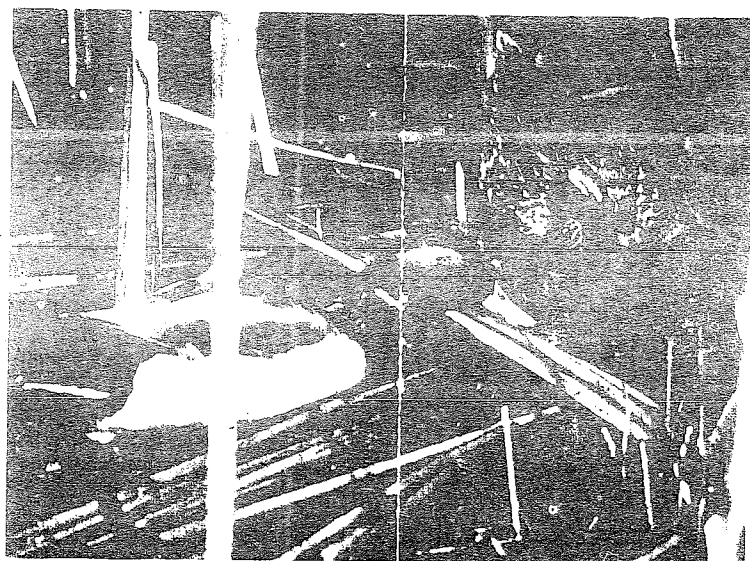
THE DEPARTMENT OF NATURAL RESOURCES, DOES NOT ENCOURAGE CONTROL OF AQUATIC VEGETATION UNLESS IT INTERFERES WITH EXISTING WATER USE. IF CONTROL IS DEEMED ABSOLUTELY ESSENTIAL, CUTTING AND PULLING OF VEGETATION IS RECOMMENDED RATHER THAN USING A CHEMICAL.

LAKESHORE PROPERTY OWNERS MAY CUT OR PULL VEGETATION IN AN AREA NOT TO EXCEED 2,500 SQUARE FEET. THIS CANNOT EXTEND MORE THAN 50 FEET ALONG THE SHORELINE, OR MORE THAN HALF OF THE LOT'S FRONT FOOTAGE—WHICHEVER IS LESS. IN ADDITION, A 15-FOOT WIDE BOAT CHANNEL MAY BE CUT TO OPEN WATER, BUT CUT VEGETATION MUST BE REMOVED FROM THE WATER.

ALL OF THESE PROJECTS CAN BE DONE WITHOUT A PERMIT. OTHER AQUATIC NUISANCE CONTROLS, HOWEVER, INCLUDING APPLICATION OF HERBICIDES, REQUIRE A PERMIT FROM THE ENVIRONMENTAL SECTION OF DNR.

DID YOU KNOW !!!!!!!

CEDAR LAKE IS THE LOWEST IT HAS BEEN SINCE THE SPRING OF 1941.

THAT THE DAM ON THE NORTH END OF THE LAKE WAS CONSTRUCTED IN THE MIDDLE OF THE 1930'S.

THE SAND BAR WENT 3/4 OF THE WAY ACROSS THE LAKE WITH HEAVY BRUSH AND TREES APPROXIMATELY 10 INCHES OR MORE IN DIAMETER GROWING UNTIL THE HIGH WATER OF 1941.

IN THE MIDDLE 30'S IT WAS DIFFICULT TO GO BY BOAT FROM THE LOWER END OF CEDAR TO THE UPPER LAKE DUE TO THE SHALLOW WATER. AT TIMES DITCHES WERE DUG IN THE SAND TO PERMIT BOATS TO GO THROUGH.

ONLY ONE BULLHEAD WAS CAUGHT AND ENTERED IN THE 1976 FISHING CONTEST.

THREE 1975 FISHING CONTEST WINNERS REPEATED AS WINNERS IN 1976. WHERE ARE THE REST OF THE FISHERMEN THAT CATCH THE "BIG ONES"?
