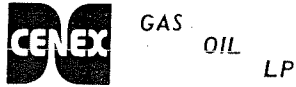

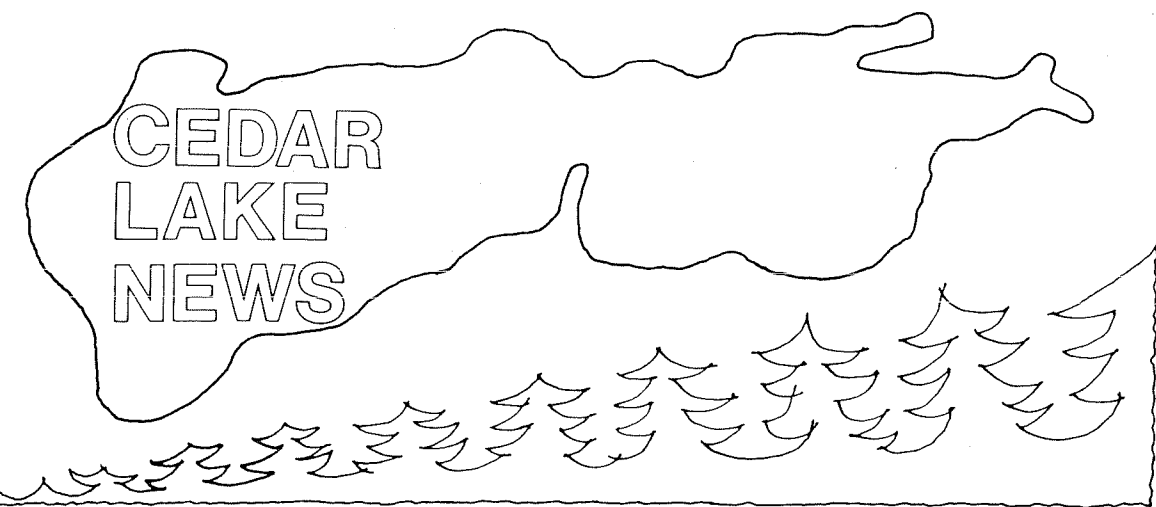

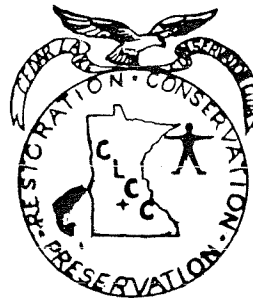

BOATERS REMINDED TO "LIGHT UP THEIR LIFE"

THE MINNESOTA DEPARTMENT OF NATURAL RESOURCES REMINDED BOATERS AND FISHERMEN PROPER LIGHTS ARE REQUIRED ON BOATS AFTER SUNSET.

KIM ELVERUM, DNR BOAT AND WATER SAFETY COORDINATOR, NOTED THAT COLLISIONS OVER THE LAST YEAR HAVE OCCURED WHEN ONE BOAT COULD NOT SEE THE OTHER BECAUSE IT EITHER WASN'T EQUIPPED WITH LIGHTS OR DID NOT HAVE THEM TURNED ON. IN ONE CASE, AN ACCIDENT RESULTED IN TWO DEATHS.

MINNESOTA LAW REQUIRES ALL BOATS TO DISPLAY LIGHTS FROM SUNSET TO SUNRISE WHEN THEY ARE ON THE WATER AND NOT DOCKED OR MOORED. MOTORBOATS, UNDER 26 FEET IN LENGTH, INCLUDING FISHING CRAFT, ARE REQUIRED TO DISPLAY A RED AND GREEN BOW LIGHT AND A WHITE STERN LIGHT WHEN THE BOAT IS UNDERWAY.

WHEN ANCHORED, ONLY A WHITE LIGHT, VISIBLE FROM ALL DIRECTIONS IS NECESSARY. NON-MOTORIZED CRAFT (CANOES, SAILBOATS, ETC.) WHETHER IN MOTION OR ANCHORED NEED ONLY DISPLAY A WHITE LIGHT.

ELVERUM NOTED THAT INEXPENSIVE BATTERY-POWERED LIGHTS ARE AVAILABLE FOR FISHERMEN WHO DO NOT HAVE AN ELECTRICAL SYSTEM ON THEIR BOAT.

"USING YOUR LIGHTS AT NIGHT", HE CONCLUDED, "IS PROBABLY THE CHEAPEST COLLISION INSURANCE YOU CAN BUY."

STATE'S LARGEST LAKES

EVER HAD AN ARGUMENT OVER WHICH OF MINNESOTA'S LAKES IS THE LARGEST? THE DEPARTMENT OF NATURAL RESOURCES LISTS THE STATE'S FIVE LARGEST LAKES IN THIS ORDER:

LAKE	SIZE IN ACRES
UPPER AND LOWER RED LAKE	288,800
MILLE LACS	132,510
LEECH	109,415
WINNEBIGOSHISH	69,821
VERMILLION	49,110

IN ADDITION, MINNESOTA'S SHARE OF LAKE SUPERIOR IS 1,315,700 ACRES AND THE STATE CLAIMS 307,010 ACRES OF LAKE OF THE WOODS.

MINNESOTA IS SECOND IN NUMBER OF BOATS

ACCORDING TO A REPORT JUST RELEASED BY THE U.S. COAST GUARD, MINNESOTA IS SECOND ONLY TO CALIFORNIA IN THE NUMBER OF LICENSED PLEASURE BOATS.

THE REPORT SHOWED MINNESOTA HAD 541,202 BOATS REGISTERED WITH THE DEPARTMENT OF NATURAL RESOURCES IN 1978. CALIFORNIA HAD 548,800 LICENSED BOATS.

A TOTAL OF 8,034,905 BOATS WERE REGISTERED IN THE U.S. DURING 1978.

OTHER STATES WITH LARGE NUMBERS OF BOATS REGISTERED ARE TEXAS, MICHIGAN, FLORIDA, AND WISCONSIN.

MINNESOTA CONTINUES TO LEAD THE NATION IN NUMBER OF BOATS PER CAPITA WITH AN AVERAGE OF ONE BOAT FOR EVERY 7.4 PERSONS.

KIM ELVERUM, DNR BOAT AND WATER SAFETY COORDINATOR, SAID THAT DESPITE THE LARGE NUMBER OF BOATS IN MINNESOTA, THE STATE HAS A LOW BOATING ACCIDENT RATE. HE SAID MINNESOTA HAS NEARLY SEVEN PERCENT OF THE NATION'S REGISTERED BOATS BUT RECORDS ONLY TWO PERCENT OF THE BOATING ACCIDENTS IN THE U.S. DURING AN AVERAGE YEAR.

WHAT IS CORN?

YOU MAY THINK YOU KNOW WHAT CORN IS, BUT POSSIBLY, YOU DO NOT. THE DICTIONARY DEFINES CORN AS THE IMPORTANT CEREAL CROP OF A PARTICULAR REGION. THUS, IN ENGLAND, CORN IS WHEAT; IN IRELAND, IT IS OATS; AND, IN NORTH AMERICA, IT'S INDIAN MAIZE. AND THERE IS A SAYING THAT CORN IS AN ODD COMMODITY: IN THE U.S. MIDWEST, IT IS MEASURED BY THE FOOT; IN THE SOUTH, BY THE FIFTH; AND ON TELEVISION, BY THE HOUR!

CHEMICAL USE IN LAKES CALLS FOR CAUTION

CITIZEN LAKE MONITORING PROGRAM

OUR CLUB RECEIVED A VERY NICE LETTER FROM THE MINNESOTA POLLUTION CONTROL AGENCY, SEEKING VOLUNTEERS FOR ITS CITIZEN LAKE MONITORING PROGRAM, A PROGRAM INTENDED TO INVOLVE THE PUBLIC IN GATHERING WATER QUALITY DATA ON MINNESOTA LAKES. CEDAR LAKE ASSOCIATION HAD BEEN SELECTED FROM AMONG THOSE FOUND IN AGENCY LAKE INFORMATION FILES.

CEDAR LAKE CLUB DECIDED TO PARTICIPATE IN THE ADVANCED PROGRAM (SECCHI DISC PLUS 4 WATER SAMPLES PER SEASON). CLARENCE HEGG VOLUNTEERED TO GET THE SAMPLES AND BEAR THE RESPONSIBILITY OF THIS PROJECT.

THE INITIAL FEE, \$10.00 FOR THE ADVANCED PROGRAM, WILL BE USED TO HELP DEFRAY THE COST OF EQUIPPING EACH PARTICIPANT. IF WATER SAMPLES ARE TO BE COLLECTED, PARTICIPANTS MUST ALSO ASSUME RESPONSIBILITY FOR BRINGING THE SAMPLES IN OR MAILING THEM IN (1ST CLASS MAIL) AFTER COLLECTION. ALL OTHER COSTS, INCLUDING STAFF TIME AND LABORATORY EXPENSES FOR THE ADVANCED PROGRAM, WILL BE BORNE BY THE AGENCY FOR UP TO THREE YEARS. WE FEEL THIS IS A VERY WORTH-WHILE PROGRAM.

1979 DUES

REMEMBER TO BE ELIGIBLE FOR THE 1979 FISHING CONTEST, AND UPCOMING BRUNCH YOUR CURRENT DUES MUST BE PAID. MOST IMPORTANT THE CLUB NEEDS YOUR INTEREST.

THE USE OF COPPER SULPHATE AND OTHER CHEMICALS FOR TREATMENT OF ALGAE AND VEGETATION IN LAKES CAN BE DONE SAFELY -- IF IT IS DONE CORRECTLY, THE DEPARTMENT OF NATURAL RESOURCES SAID THIS WEEK.

HOWARD KROSCH OF THE DNR'S ECOLOGICAL SERVICE SECTION SAID THE DEPARTMENT DOES NOT PROMOTE THE USE OF CHEMICALS IN LAKES BUT RECOGNIZED THAT SERIOUS NUISANCE CONDITIONS OCCUR.

"USE OF THE CHEMICALS IS ALLOWED PROVIDING THEIR USE WILL IMPROVE RECREATION AND SO LONG AS NO SIGNIFICANT DAMAGE IS DONE TO THE LAKE'S FISH AND WILDLIFE POPULATIONS," HE SAID.

"CHEMICALS, LIKE OTHER TOOLS, ARE SAFE IF USED CORRECTLY BUT CAN BE DANGEROUS AND DESTRUCTIVE IF USED IMPROPERLY," HE EMPHASIZED.

THE USE OF ANY CHEMICALS IN MINNESOTA LAKES AND STREAMS REQUIRES A PERMIT FROM THE DEPARTMENT OF NATURAL RESOURCES. WHEN AN APPLICATION FOR CHEMICAL USE IS RECEIVED, SEVERAL PAGES OF INSTRUCTIONAL MATERIAL ARE SENT ALONG TO THE APPLICANT.

ONE OF THE MOST COMMONLY APPLIED FOR PERMITS IS FOR USE OF COPPER SULPHATE TO CONTROL ALGAE. DETAILED INSTRUCTIONS ARE PROVIDED BY THE DNR REGARDING THE CORRECT METHOD OF APPLYING THIS CHEMICAL SO AS TO ACHIEVE THE DESIRED RESULT WITHOUT DAMAGING FISH LIFE.

"MOST PROBLEMS RESULTING FROM CHEMICAL APPLICATION OCCUR BECAUSE THE PERSON USING THE CHEMICAL DOES NOT READ THE LABEL ON ITS CONTAINER AND IS CARELESS WHEN APPLYING IT," SAID KROSCH. HE ADDED THAT USE OF ANY PESTIDE CHEMICAL IN A MANNER INCOSISTENT WITH LABEL INSTRUCTIONS IS A VIOLATION OF FEDERAL LAW.

DNR SEEKS HELP ON LOON SURVEY

A SURVEY OF THE COMMON LOON -- MINNESOTA'S STATE BIRD -- WILL BE CONDUCTED BY THE DEPARTMENT OF NATURAL RESOURCES IN MINNESOTA THIS SUMMER, ACCORDING TO CARROL HENDERSON, DNR NONGAME WILDLIFE PROGRAM SUPERVISOR.

PURPOSE OF THE PROJECT IS TO DETERMINE THE CURRENT DISTRIBUTION AND ABUNDANCE OF LOONS. MINNESOTA IS BELIEVED TO HAVE MORE NESTING LOONS THAN ANY OTHER OF THE CONTIGUOUS 48 STATES, HENDERSON SAID.

IN ADDITION TO HAVING DNR PERSONNEL COLLECT LOON INFORMATION, PRIVATE CITIZENS AND CONSERVATION ORGANIZATIONS ARE BEING ENCOURAGED TO PARTICIPATE IN THE SURVEY.

SPECIAL LOON OBSERVATION CARDS ARE BEING PRINTED AND WILL BE DISTRIBUTED TO VOLUNTEERS ON REQUEST. THE CARDS WILL BE USED TO REPORT THE PRESENCE OF LOON BREEDING PAIRS, NEST SITES, AND LOONS ACCOMPANIED BY YOUNG.

1 EGG
1 CUP SOUR MILK OR BUTTERMILK
1 1/2 CUPS RAW RHUBARB (FINELY CUT)
1 TSF. SODA
1 TSP. VANILLA
2 CUPS FLOUR

MIX AS USUAL AND BEFORE PUTTING INTO OVEN TOP WITH MIXTURE OF 1/2 CUP WHITE SUGAR AND 1 TSP. CINNAMON. BAKE 45 MINUTES AT 350 DEGREES

CHOCOLATE CRUMBLE BARS

1/2 CUP OLEO
3/4 CUP SUGAR
2 EGGS
1 TSP VANILLA
3/4 CUP FLOUR
2 TBLSP COCOA
1/4 TSP BAKING POWDER
CREAM
SIFT

PUT INTO 9 X 13 PAN AND BAKE 15 MINUTES AT 350 DEGREES. COVER WITH MINIATURE MARSHMELLOWS. BAKE 3 MIN 350 DEGREES. COOL
SPREAD WITH 1 CUP CHOCOLATE CHIPS AND 1 CUP PEANUT BUTTER MELTED. 1 1/2 CUPS RICE DRISPIES COULD BE ADDED TO CHOCOLATE MIXTURE.
